WHEREAS, one fourth of the appropriations for the 2005 Sewer Utility Budget exclusive of any appropriation made for interest and debt redemption charges, capital improvements is the sum of \$ 255,002.

Ordinance #3-2006 - W.B.B.I.D. 2006 Budget Introduction

The following Resolution was adoption on a motion made by Glaser, seconded by Buoye:

RESOLUTION #3-2006

INTRODUCING AND APPROVING THE BUDGET OF THE WASHINGTON BOROUGH SPECIAL IMPROVEMENT DISTRICT

WHEREAS, the governing body of the Borough of Washington on June 4, 2003 adopted Ordinance #7-2003 creating the Washington Special Improvement District; and

WHEREAS, the governing body of the Borough of Washington designated the Washington Borough Business Improvement District Management Corporation as the District Management Corporation for the Special Improvement District; and

WHEREAS, the Washington Borough Business Improvement Management Corporation Board of Directors have approved a 2006 Special Improvement District Budget for submittal to Borough Manager for submission to the Mayor and Council of the Borough of Washington for their consideration; and

WHEREAS, pursuant to N.J.S.A. 40:56-80 and N.J.S.A. 40:56-84, the governing body of the Borough of Washington is required to approve the budget and fix the time and place for the holding of a public hearing upon the budget;

WHEREAS, the governing body of Washington Borough has determined that at least one (1) week prior to the hearing a complete copy of the proposed budget shall be: (a) posted on the bulletin board in the Borough Municipal Building; (b) made available to each person requesting the same before and during the public hearing; (c) a copy of the budget shall be advertised along with the date time and place of the hearing in a newspaper published in the county and circulating in the municipality at least 10 days prior to the hearing; and (d) the hearing shall be held not less than 28 days after the approval of the budget.

NOW, THEREFORE, BE IT RESOLVED, the governing body of the Borough of Washington that:

(a) The Washington Borough Special Improvement District budget is hereby introduced and approved by the governing body of the Borough of Washington for the period of January 1, 2006 – December 31, 2006 in the amount of \$214,750.00 for the Washington Borough Business Improvement District Management Corporation.

A special assessment will be imposed and will be collected with either the regular tax payment (or payment in lieu of taxes), or otherwise, on properties located within the Borough of Washington as set forth within Ordinance #7-2003 as amended from time to time. The Assessment for 2006 shall be in the amount of \$176,750.00 with \$38,000.00 being used from other revenue sources. (Surplus - \$16,750; Car Show – \$2,450; Festival in the Borough \$18,000; Just Desserts - \$500; Town-wide Yard Sale - \$300).

- (2) Payments received by the Borough of Washington for the District will be transferred to the Washington Borough Business Improvement District Management Corporation to be expended in accordance with the approved budget; and
- (3) The Borough Clerk will be authorized to forward a certified copy of the adopting resolution to Washington Borough Business Improvement District Management Corporation, the Warren County Board of Taxation, and the Director of the Division of Local Government Services in the State of New Jersey Department of Community Affairs after the public hearing and adoption by a majority vote of the full membership of the governing body.
- (4) The proposed Budget is as follows:

Washington Business Improvement District Management Corporation Proposed "2006" Budget

<u>Management (92,500)</u>: This consists of a full time Executive Director (\$60,000) Part-time staff (\$15,000), Maintenance Workers (\$7,500) and Payroll Taxes (\$10,000).

<u>General Administration (\$28,200)</u>: To cover the cost of an accountant, legal and professional services and office supplies and equipment, office rent and repairs, telephone, janitorial, utilities, conferences and dues, and fees.

<u>Insurance (\$3,500)</u>: Liability and corporate insurances, and health insurance for Executive Director.

<u>Promotions and Public Relations (\$65,050)</u>: To promote and market the district as a premier destination to shop and conduct business. This includes concert series, newsletters, banners, and advertisements.

<u>Quality of Life (\$12,000)</u> Clean & Safe; Directed towards cleaning services, and common area environmental improvements. **Parking & Pedestrian Improvement:** this is a focus on parking management, pedestrian crossing upgrades, signage and lighting.

Discussion: Manager Sheola explained the B.I.D.'s budget. There will be a reduction in the assessment to the businesses this year based on utilizing \$ 38,000 from revenue sources. The Assessment for 2006 shall be in the amount of \$ 176,750.00.

Councilman Turner questioned whether there would be any monies contributed from the Borough's budget? Manager Sheola indicated that there would be none. Councilman Turner also requested that it would be helpful to the Council to receive any reports or minutes of the B.I.D. meetings and activities.

Councilwoman Glaser was interested in having budget to actual figures monthly. Mr. Sheldon noted that the budget to actual are still a little off + or – perhaps 10%.

BE IT THEREFORE RESOLVED, that Council does hereby authorize an interest charge not to exceed eight (8%) percent per annum on the first \$ 1,500.00 of the delinquency and eighteen (18%) percent per annum on any amount in excess of \$ 1,500.00 upon all delinquent installments; and

BE IT ALSO RESOLVED, that Council does hereby authorize a penalty to be charged to a taxpayer with a delinquency in excess of \$ 10,000.00 who fails to Pay that delinquency prior to the end of the calendar year. The penalty so fixed shall not exceed six (6) percent of the amount of the delinquency.

BE IT FUTHER RESOLVED, that any installments received after the expiration of the grace period, and such grace period shall be the period starting with the second day and ending on the tenth (10^{th}) day of the month in which taxes are due, shall bear interest at the applicable interest rate from the original due date.

BE IT FURHTER RESOLVED, that the Tax Collector of the Borough of Washington is hereby authorized to conduct the annual sale of delinquent taxes for the Calendar Year of 2005.
