BOROUGH OF WASHINGTON, WARREN COUNTY, NEW JERSEY WASHINGTON BOROUGH COUNCIL MINUTES – MAY 16, 2006

The Regular Meeting of the Borough Council of Washington, Warren County, New Jersey was held in the Council Chambers of Borough Hall at 8:00 P.M.

Roll Call: Woykowski, Buoye, Oakley, Van Deursen and Turner – 5 Present.

Absent: Housel and Glaser – 2 Absent.

Mayor Van Deursen read the following Statement into the Record:

"The requirements of the 'Open Public Meetings Law 1975, Chapter 231 have been satisfied in that adequate notice of this meeting has been published in the Star Gazette and posted on the Bulletin Board of Borough Hall stating the time, place and purpose of the meeting as required by law.

COUNCIL APPEARANCE:

<u>Municipal Court – The Honorable J. Edward Palmer, Judge and Virginia Cortese,</u> Court Administrator

Judge Palmer gave a summarization of the Municipal Court activities for the past year up to present. Traffic violations are down from last year due to the Police not participating the Click It or Ticket Program last year. They handled seventy-five criminal cases this past year.

Judge Palmer thanked the governing body for appointing Mrs. Lisa Rudd as full-time Deputy Court Administrator. The Administrative Office of the Courts is requiring mandatory certification for Court Administrators. Virginia Cortese, Court Administrator explained the certification process to the governing body which encompasses a three year training course. Mrs. Rudd began her training classes. A written and oral examination is required and a court improvement project that she will design and implement.

Judge Palmer addressed a matter of truancy of our youth cutting school. He explained how he is presently handling these matters bringing in the parents, the child and the principal. The way the law is presently set up the parent is the one who would ultimately go to jail. He presently refers these cases to the Family Division for counseling.

Judge Palmer brought to the Council's attention a new statute that would allow the governing body to adopt a curfew for children during school hours. The child can be punished with perhaps doing community service work.

Officer Magyar was also present and supported Judge Palmer's recommendation. Officer Magyar had done research on the number of juvenile complaints they have dealt with this past year and the number was between 200 to 250 calls. The majority of complaints were between 9 PM to midnight in such areas as Quick Check and Dunkin Donuts in addition to the truancy from school.

This matter will be referred to Attorney Cushing for his review and recommendation.

Judge Palmer recognized the excellent job Court Adminsitrator, Ginny Cortese and Lisa Rudd for the fine job they do in administering the court. The staff is to be commended for their efforts.

Mayor Van Deursen on behalf of the governing body thanked Judge Palmer and Officer Magyar for their excellent presentation.

AUDIENCE:

Mayor Van Deursen entertained remarks from the audience on items that do not appear on the meeting agenda.

Robin Klimko, 35 Marble Street commented on the recommended curfew and supported the idea of instituting it. She outlined for Council a multitude of items at the end of S. Prospect Street that should be looked into. The road, in her opinion, is an absolute mess. She stressed all the problems that were encountered with the contractor during the construction and the fact that they not only utilized her yard to park their vehicles but damaged the property. Garbage was left strewn all over her yard as well. They left her property with no grass as a result of the damage. Her neighbors sidewalk was damaged and should be repaired. Her husband spent the better part of one of their weekends raking their yard trying to put it back into some semblance of order. The equipment tore up the roadway to the point where she has incurred damage to her car as well. Mrs. Klimko felt that overall the contractor gave the Borough very poor workmanship and left everything a total mess.

Council suggested that she meet with Borough Manager Sheola and that a claim be filed against their insurance company for restitution. A meeting was scheduled for the following Monday.

<u>James Prendergast, 97 Flower Avenue</u> questioned the status of the Vara Soccer field in Washington Meadows. He asked when the work was going to be scheduled for this field. They are presently signing children up for the soccer program and that field is going to be needed.

Attorney Cushing noted that legally the Borough cannot do the work themselves. Washington Meadows is under the gun to do the work.

Mr. Prendergast asked whether the field will be available for the fall season? Engineer Miller updated Council on the meeting they finally had with Centex Home at the Borough Hall and the on-site meeting. The field will now be sodded versus the seeding previously requested.

The field itself was discussed as to whether it was a regulation field? Councilman Turner noted that the Planning Board did not specify that it be a regulation field when the land was dedicated to the Borough.

Attorney Cushing commented on the legalities of the issues with regard to this development and recommended that Council avoid going into a lawsuit.

Hearing no further remarks from the audience, it was moved by Turner, seconded by Oakley that the audience portion of the meeting be closed.

PRESENTATION:

Harry R. Pool, Jr., Vice-Chairman of the Pollution Control Authority presented the Borough with a Solid Waste and Stormwater Management Grant in the amount of \$5,000.00. This grant is to be utilized for something in the environmental area. The only stipulation with this grant is that the Authority be given an accounting of what the grant will be used for.

On behalf of the governing body Mayor Van Deursen thanked Mr. Pool for this generous grant.

<u>Ordinance #10-2006</u> – Amending the Land Development Ordinance of the Borough of Washington to Facilitate the Provision of the Third Round of Affordable Housing in Connection with the Residential and Nonresidential Growth and Development (First Reading)

An ordinance amending the Land Development Ordinance regarding the third round of affordable housing was introduced by Councilwoman Oakley.

It was further moved by Oakley, seconded by Buoye that the Clerk read Ordinance #10-2006 by title only.

Roll Call: Woykowski, Buoye, Turner, Oakley and Van Deursen.

Ayes: 5, Nays: 0. Motion carried.

The Clerk read Ordinance #10-2006 entitled, "AN ORDINANCE OF THE BOROUGH OF WASHINGTON AMENDING THE LAND DEVELOPMENT ORDINANCE OF THE BOROUGH OF WASHINGTON TO FACILITATE THE PROVISION OF THIRD ROUND AFFORDABLE HOUSING IN CONNECTION WITH RESIDENTIAL AND NONRESIDENTIAL GROWTH AND DEVELOPMENT."

Council Discussion: Manager Sheola explained that this amendment sets up the contribution in lieu of construction.

Councilman Buoye pointed out a typo in the ordinance that will be corrected prior to publishing.

Hearing no further discussion it was moved by Buoye, seconded by Oakley that Ordinance #10-2006 be approved on first reading.

Ordinance #11-2006 – Amending AR-7 Zone (First Reading)

An ordinance amending the AR-7 Zone was introduced by Councilwoman Oakley.

The Clerk read Ordinance #11-2006 entitled, "AN ORDINANCE TO AMEND SECTION 94-40 – BUFFERS – OF THE CODE OF THE BOROUGH OF WASHINGTON AS PERTAINING TO THE AR-7 ZONE."

Council Discussion:

Councilman Buoye questioned whether it should read "minimum" rather than "maximum". Council discussion followed at which time it was the consensus of Council that the word "maximum" should be changed to read "minimum".

Hearing no further discussion it was moved by Oakley, seconded by Buoye that Ordinance #11-2006 be approved on first reading with the correction so noted.

It was further moved by Buoye, seconded by Oakley that Ordinance #11-2006 be published in the Star Gazette on May 25, 2006 as required by law and that the public hearing be scheduled for June 6, 2006.

REPORTS:

It was moved by Turner, seconded by Oakley that the Road Department, Fire Prevention, Police (3), Municipal Court (2), Recreation Commission, Collector-Treasurer's, A & E O.T., Borough Manager's and Borough Engineer's reports be accepted as presented and filed.

Discussion: Councilman Turner addressed the Recreation Commission report and indicated that this report does not give him any idea of how they are doing. This report is a report from the Treasurer on the financial end of Recreation Commission. As a liaison member to the Recreation Commission there is a certain level of frustration he has observed from the Recreation Commission members. There are issues that should be addressed in a report that should be generated by the Recreation Commission. Councilman Turned noted that he asked that two members from the Recreation Commission be present this evening. There was no representation from the Recreation Commission in the audience.

Councilman Turner asked what the next move was with regard to the bids for the Streetscape project? Engineer Miller noted that the bids will be opened on June 15th and that a pre-bid meeting is scheduled for June 2nd at 2 PM. Councilman Turner still suggested that perhaps some of the items could be purchased ourselves.

Engineer Miller noted that on Sunrise Terrace there are still some minor items to take care of before the final topcoat is scheduled for next Monday.

The Belvidere Avenue project was discussed. The second re-bid was also too high. The engineer noted the alternative options. Council can request more in state aid or the road could be placed out to bid in sections. The engineer noted that the bid prices are coming in high in several of the municipalities. Another reason why the bids are coming in high is due to the gasoline prices. If the project is sectioned off Council suggested doing from the Borough line down to Carlton Avenue. Mr. Miller will check with the State on the options discussed and report back to Council.

Councilman Turner noted that 2,000 tickets were ordered for the court. These tickets were ordered for the Click-It-Or-Ticket Program.

Councilwoman Woykowski was pleased with the Police Chief's memorandum on the North Prospect Street speeding problem. The report reflects the results of checking the speed limit during different times of the day.

Councilman Turner noted that it would be interesting to know how many tickets were issued. Engineer Miller stated that the speed results would be helpful.

Councilwoman Oakley noted that there have been no responses from the Fire Department of Emergency Squad with regard to speed humps to date.

State Aid applications were discussed and the following streets were proposed: Belvidere Avenue for additional funding or what is known as discretionary funding, North Lincoln Avenue from Rt. 57 to Johnston Street, W. Church Street and Grand Avenue.

Vote on Reports: Ayes: 5, Nays: 0. – Motion carried.

VOUCHERS:

Mayor Van Deursen entertained additions or questions of the vouchers and claims for payment.

Several questions arose with regard to the vouchers and claims, all of which were answered. Councilwoman Woykowski suggested more of an explanation on the fees charged by the planner on the claims list. Councilman Turner noted that the purchase of a dogwood tree for the Shade Tree Commission was charged to the Planning Board. This will be corrected. The purchase of the bicycle for the Police Department by the B.I.D. was discussed. It was noted that an anonymous donor purchased by bicycle.

It was therefore moved by Buoye, seconded by Oakley that that the vouchers and claims be approved for payment in the amount of \$1,007,921.78 as reflected in the debit/credit memorandum on file in the Collector/Treasurer's office.

<u>Resolution #112-2006 – Requesting Legislation to Impose Spending Limits on State</u> <u>Budget</u>

The following Resolution was moved by Turner, seconded by Oakley and adopted:

RESOLUTION #112-2006

RESOLUTION OPPOSING EXCLUSION OF STATE FROM CAP LAW

WHEREAS, N.J.S.A. 401A:4-45 et seq. declares that it is the policy of the legislature that spiraling costs of local government must be controlled to protect the homeowners of the State and enable them to maintain their homesteads; and

WHEREAS, N.J.S.A. 40A:4-45.2 prohibits Counties and Municipalities from increasing their final appropriations by more than 2.5% or the cost-of-living adjustment, whichever is lesS, over the previous year's appropriations, which is referred to as the "CAP Law"; and

WHEREAS, N.J.S.A. 4-45.2 sets forth the items of appropriations that must be included in the "CAP" which include amounts of revenue generated by an increase in assessments; amounts approved by referendum, expenditures for the assumption of any service or function of a local public utility; and

WHEREAS, local elected officials are extremely aware of the burden imposed upon their taxpayers and exercise appropriate fiscal and community responsibility in the adoption of their respective budgets; and

WHEREAS, it is inconceivable the State of New Jersey government does not have the same or similar law limiting how its budget increases from year-to-year, or does the State have a "CAP law" to limit its appropriations; and

WHEREAS, the State of New Jersey is not keeping up with the increases in state aid to municipalities and counties as mandated in law; and

WHEREAS, without limitations on the amount the Government of the State of New Jersey may increase its budget, taxpayers are vulnerable to rising tax burden in every year; and

WHEREAS, in the spirit of tax relief, the State of New Jersey should voluntarily subject itself to the same financial controls that it has imposed on Municipalities, Counties, Authorities and School Districts.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Washington, County of Warren, State of New Jersey as follows:

- 1. It requests that legislation be enacted to impose limits on the annual New Jersey State Budget to include spending limitations comparable to those required of Municipalities, Counties, Authorities and School Districts; and
- 2. A certified copy of this resolutions be forwarded to Governor Jon Corzine, the representative of the 30th legislative district, all New Jersey Boards of Chosen Freeholders and all 566 municipalities in the State of New Jersey.

WHEREAS, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any County of Municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the Adoption of the budget; and

WHEREAS, said Director may also approve the insertion of any item of appropriation for equal amount.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Washington, in the County of Warren, State of New Jersey, hereby request the Director of Local Government Services with the Department of Community Affairs to approve the insertion of an item of revenue in the budget of the year 2006 in the sum of \$5,000.00 which item is now available as a revenue from the Warren County Pollution Control Financing Authority for solid waste or Stormwater Management programs.

WHEREAS, the voters of Washington Borough rejected the current expense and capital outlay budget designated as the General Fund, by a vote of 166 Yes votes and 218 No votes; and

WHEREAS, the total votes cast of the four municipalities comprising the Warren Hills School District rejected the current expense and capital outlay budget, designated as the General Fund by a total vote of 866 Yes votes and 1034 No votes; and

WHEREAS, the same Warren Hills Regional School Board of Education transmitted an official copy of the rejected current expense and capital outlay budget designated as the General Fund and documentation to the Borough Council of the Borough by April 21, 2006; and

WHEREAS, the Mayor and Borough Council of the Borough of Washington have reviewed information on the current expense and capital outlay budget, designated as the General Fund as submitted in the General Fund; and

WHEREAS, careful consideration has been given to the information received from the Board of Education, with a view toward providing a thorough and efficient system of education in the school system of the Warren Hills Regional School District.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Washington, in the County of Warren, State of New Jersey as follows:

1. The tax levy amount of \$ 16,991,299 on the ballot was rejected by the voters for the General Fund (base budget);
