COUNCIL APPEARANCE

<u>Highlands Council – Eileen Swan</u>

Mayor Van Deursen introduced Ms. Swan and asked her to give an overview to Council on the Highlands Master Plan and how the Highlands Council hopes to progress in the future.

Ms. Swan thanked the Governing Body for inviting her to the meeting. It is a great opportunity to discuss the work of the Highlands Council. The Highlands Council released the draft master plan in November, 2006. A re-draft was done based on comments that were received. On November 30th the Highlands Council released the final master plan. The public comment period will be until February 28, 2008; with three public hearings scheduled. The plan could be could be adopted as early as April/May 2008. There is mandatory compliance for municipalities that fall into the preservation area; and optional compliance for municipalities in the planning area. Washington Borough is entirely in the planning area.

Ms. Swan explained that the re-draft is different in organization then the previous draft. In terms of what the Borough will be considering; the Borough will have two choices when looking at planning to be consistent with the state plan; you can endorse the Highlands Master Plan or the Borough can opt for plan conformance. Any benefits received by plan endorsement will automatically accrue to the Borough with plan conformance.

In addition to receiving all benefits by plan endorsement; plan conformance will offer additional benefits such as planning grants, legal shield and legal representation, transfer of development rights, and priority for Green Acres funding. Ms. Swan stated that the focus of

redevelopment should be communities such as the Borough. A good example is existing Brownfields; this would be an area that would be looked at to revitalize and correct. Mayor Van Deursen explained that the purpose of the plan is to preserve environmentally sensitive areas. The Borough respects that and we also have an opportunity for more growth in our downtown. The Highlands is also interested in sending development to the right areas. They are very interested in helping the Borough by providing us with grant money to do the exploration and the planning. It costs the Borough a lot of money to do the things that we want to do. The Borough will need to consider this seriously.

Councilman Higgins asked what kind of relationship the Highlands Council has with other state agencies. Ms. Swan stated that they are required to consider our plan and work with the Highlands. If the Borough considers plan conformance we would be advocates for the Borough with state agencies.

Mayor Van Deursen thanked Ms. Swan for her informative presentation.

ORDINANCE # 13 - 2007

AN ORDINANCE TO AMEND CHAPTER 85-81 OF THE CODE OF THE BOROUGH OF WASHINGTON, ON STREET PARKING FOR HANDICAPPED PARKING

WHEREAS the handicapped parking designation in front of 9 - 11 School Street is no longer needed for the purpose for which it was installed; and

WHEREAS the Mayor and Council deem it to be in the best interest of the Borough to remove the restriction to permit additional parking on the street; and

WHEREAS a request has been made by a medical doctor on behalf of his patient to install handicapped designated parking in front of 49 State Street; and

WHEREAS the Mayor and Council have determined that there is sufficient justification to designate a handicapped parking space at 49 State Street and that it is in the best interest of the Borough to do so.

NOW THEREFORE BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF WASHINGTON, IN THE COUNTY OF WARREN, NEW JERSEY THAT SECTION 85-81 OF THE CODE OF THE BOROUGH OF WASHINGTON BE AMENDED AS FOLLOWS:

- 1) The following paragraph is to be deleted in its entirety: "School Street: west side, beginning at a point 125 feet north of the northerly curb line of East Washington Avenue at its intersection with School Street and extending 22 feet northerly therefrom."
- 2) The following paragraph is to be added: "State Street: southern side, beginning at a point 335 feet east of the easterly curb line of Grand Avenue and extending 22 feet easterly therefrom.
