COUNCIL APPEARANCE:

Shade Tree Commission – Jeremy Summitt

Mr. Summitt gave the Mayor and Council a brief synopsis of the accomplishments of the Shade Tree Commission for the year 2006. The Shade Tree Commission had the tree inventory completed during the year. This is a huge tool for the Commission and will help them manage their trees in a much more effective manner. This year the Shade Tree Commission also applied for the Cool Cities grant and was awarded \$25,000.00 for the year 2007. Mr. Summitt explained that during the tree inventory many trees were found to be in need of being replaced; this grant will allow the commission to replace these trees during the spring of 2007.

Councilman Cioni inquired as to where the new trees will be place and what species of trees will be planted. Mr. Summitt stated that the tree plantings will be based on the inventory and the trees that need to be replaced will be planted first. The types of trees to be planted vary; however the grant indicated that the Borough will plant ten different species of trees. The new trees also come with a one year warranty.

Mayor Van Deursen thanked Mr. Summitt for his informative report.

It was moved by Oakley, seconded by Turner that the Council acknowledge, receive and file the Borough Manager's, Borough Clerk's, Police Activity, Recreation Commission, Veolia Monthly Operations, Treasurer's Report, Zoning Code Enforcement, Highway Department and Executive and Administrative Report

Council Discussion:

Councilman Higgins asked Manager Sheola when the Borough will be going out for bids for the Borough Garage. Manager Sheola stated that the committee will be attending an open house for the DPW garage after which they will meet and come up with a more solid number.

Councilman Higgins asked the Borough Manager is Ebay is the only way the Borough sells municipal items. Manager Sheola indicated that sometimes the Borough will have a public auction and sometimes an auction is held on Ebay. Councilman Higgins asked Manager Sheola for the backup that goes with the letter from the Borough Engineer regarding the park drainage issue. Manager Sheola will make a copy of the backup for Councilman Higgins.

Mayor Van Deursen asked Manager Sheola why the Speed Machine on loan from the Township is no longer on North Prospect. Manager Sheola indicated that the Borough was only able to borrow the machine for a few days. Mayor Van Deursen suggested borrowing the machine again as soon as possible and placing the machine facing north in order to obtain the speed of the southbound traffic.

At this time a motion was made by Housel, seconded by Woykowski that the speed machine be obtained for measuring southbound traffic on Prospect Street; as long as it fits in with the Township's schedule. It is recommended that this be done by the end of February.

Councilman Higgins questioned the balance in the Recreation Commissions Accounts. He asked if the balance in the Recreation account was \$53,000.00. Manager Sheola stated that he would verify that amount with the Borough Treasurer and will have an answer by the Budget Meeting on Saturday, February 10th.

VOUCHERS & CLAIMS:

Mayor Van Deursen entertained questions or additions to the vouchers and claims for payment.

Councilman Higgins questioned the bill for Smith Motors. Manager Sheola stated that this was a bill for break repair on one of the police cars. Councilman Higgins inquired about the Engineering costs for Fund 04 in the amount of \$41,333.00 for work that dates back to July of 2006. Councilman Higgins asked why the Borough is not paying these bills on time. Manager Sheola stated that some of the bills came in late and others may have been held until the money was available to pay them. Councilman Higgins asked if there was a policy when bills are to be submitted and presented for payment. Manager Sheola stated the bill should be sent to the Borough and paid as expeditiously as possible.

Councilman Higgins also stated that there are nine different bills charged to the Streets General Account. Councilman Higgins asked what that account is. Manager Sheola stated that it is a type of Misc. account. These bills are for the engineering work done in 2006 for road work scheduled to be completed in 2007. Councilman Higgins also stated that there were only two roads scheduled to be worked on in 2007 so why is there nine bills charged to the Streets General Account. Manager Sheola indicated that the reason is because the Borough was waiting until the end of the year to transfer money into this account. Councilman Higgins stated that the Borough could not transfer money into a capital account.

Councilman Housel indicated that Ordinance number 8-2005 was for Myrtle Avenue and none of these other bills should be charged to Ordinance 8-2005. Manager Sheola stated that he believed Ordinance 8-2005 was a large multi-purpose ordinance.

Councilwoman Woykowski stated that there are too many bills being applied to Ordinance 8-2005 and Council needs to know what exactly is being charged to this account. Manager Sheola stated he will need to go back and look at each voucher and will have a report prepared by Saturday's budget meeting.

Councilwoman Oakley stated that this is something that occurs often. Bills submitted to the Borough for payment need to be submitted in a timely manner.

Councilwoman Woykowski also indicated that the bill list should be as detailed and as accurate as possible. Manager Sheola informed Council that right now the finance department is working off of Excel spreadsheet versus the regular finance software until the year end process is completed.

Councilman Higgins stated that he would like to amend his motion to pay the bills with the exception of those items under Fund 04 Fiscal Engineering until further clarification is obtained; this motion was seconded by Councilman Turner.

Roll Call: Woykowski, Higgins, Housel, Cioni, Van Deursen, Oakley, and Turner.

Hearing no further comments it was therefore moved by Higgins, seconded by Oakley that the vouchers and claims be paid in the amount of \$1,866,725.59 as reflected in the debit/credit memorandum on file in the Collector-Treasurer's office. This amount does not include the items in the Fund 04 Fiscal Engineering account.

OLD BUSINESS:

Park Drainage Project

This item was tabled until the February 20, 2007 Meeting when the Engineer will be present.

Phase II Sanitary Sewer Rehabilitation NJDEP Approval Letter

Manager Sheola explained the communication from the NJDEP stating that the state has completed all necessary inspections and all payments have been made to the Borough by the Environmental Infrastructure Trust Fund. Councilman Higgins commented that this was a very favorable report.

NEW BUSINESS

Petition to Governor Re: Change in School Funding Formula

Councilman Turner stated that this petition is basically a moot point due to Governor Corzine abandoning the possible change in school funding formulas. Councilman Higgins suggested that a Resolution be adopted and sent to the Governor stating that the Borough of Washington would like to see him continue his effort to adopt changes in the school funding formula.

Timing of Sub-Committee Meetings

Councilman Turner stated that he would like the Council's opinion on holding committee meetings in the late afternoon or during the evening hours. Mayor Van Deursen explained that most committee meetings are held during the evening hours with the exception of the Redevelopment Committee due to the dynamics of the committee. Councilwoman Woykowski stated she has concerns over this meeting being held during the day the public's inability to attend or have input during these meetings. Most people work during the day. Mayor Van Deursen stated that this topic can be revisited by the Redevelopment Committee to see if everyone would be in favor of moving the time of this meeting.

Policy on Sub-Committee Spending of Taxpayer Dollars

Councilman Turner explained that this was due to the spending of grant money and Council not having a clear view of what was being spent. This concern has been taken care of by the report generated by the Manager recently. Councilman Housel asked if any grant money appropriated by the Borough needs to be approved by Resolution. The Borough Attorney indicated that yes that would need to be done by Resolution.

Councilman Woykowski stated that in addition when grant applications are submitted for Council approval all of the supporting documentation needs to be attached.
