BOROUGH OF WASHINGTON, WARREN COUNTY, NEW JERSEY WASHINGTON BOROUGH COUNCIL MINUTES – July 17, 2007

The Regular Meeting of the Borough Council of Washington, Warren County, New Jersey was held in the Council Chambers of Borough Hall at 8:00 P.M.

Deputy Mayor Turner led everyone in the flag salute.

Deputy Mayor Turner read the following Statement into the Record:

"The requirements of the 'Open Public Meetings Law, 1975, Chapter 231 have been satisfied in that adequate notice of this meeting has been published in the Star Gazette and posted on the Bulletin Board of Borough Hall stating the time, place and purpose of the meeting as required by law.

MINUTES:

Councilwoman Woykowski motioned to accept the minutes of the Regular Meeting of June 19, 2007, Executive Session June 19, 2007, Regular Meeting of July 3, 2007, and Executive Session July 3, 2007. This motion was seconded by Councilman Higgins.

Roll Call: Woykowski, Higgins, Turner, and Housel.

Ayes: 4, Nays: 0 Motion Carried.

COMMUNICATIONS:

The following communications were entered into the Record:

- 1. NJLM Re: Sales Tax Repeal and Other Information from the DLGS
- 2. NJLM Re: Ground Water Quality Standards

Deputy Mayor Turner entertained a motion to acknowledge, receive and file the communications.

It was moved by Woykowski, seconded by Higgins that the communications be acknowledged, received and filed.

Ayes: 4, Nays: 0.

AUDIENCE:

Deputy Mayor Turner entertained remarks from the audience on items that were not on the agenda.

Grace McGinnis – 57 Grand Avenue

Ms. McGinnis asked Council if the Carlton Avenue reconstruction was completed. She stated that the center dividing line has not been painted. Council informed Ms. McGinnis that Carlton have is complete and there has never been a center dividing line on Carlton Ave.

Mr. Racz – 109 W. Stewart Street

Mr. Razc stated the work that was scheduled to be done on his sidewalk has not been completed. Manager Corica explained to Council that the work was scheduled to be done on Friday however Mr. Racz stated that he did not want the dirt delivered on Friday due to a forecast of rain. The Zoning Officer's community service workers were only able to do the work on Friday. Deputy Mayor Turner requested that Manager Corica schedule the DPW Department do the work for Mr. Racz as soon as possible.

Bob Cammarota - 47 Alvin Sloan Ave

Mr. Cammarota asked for an update on the property in Washington Meadows that has not been maintained. He stated that someone cut the grass partially but the job was never completed. Council discussed whether or not the Borough has taken over that property from Washington Township. Manager Corica stated that it is Township property as it is not on the Borough's tax rolls. Council stated that there was never an Ordinance adopted by the Borough to take over that piece of property. Manager Corica stated that our own DPW has been mowing the lawn as a courtesy. Councilman Higgins suggested that the DPW finish the job of mowing the lawn.

Councilman Housel stated that he feels it is still a Township property and that they are responsible for maintaining it. He suggested calling the Mayor of the Township and discussing it with him. Deputy Mayor Turner or Manager Corica will call the Township Mayor to discuss.

<u>Gina Appleby – 28 Willow Street</u>

Ms. Appleby informed Council that even though the Borough has a pedophile free zone in place; pedophiles are still moving in to the Borough. Ms. Appleby asked Council why this is happening. She asked if Council had gotten confirmation if other authorities were aware of the Borough's Ordinance. Deputy Mayor Turner stated that the previous manager had verbally confirmed.

Councilwoman Woykowski explained to Ms. Appleby the major issue the Borough is facing is state law supercedes any local law. The probation officers do not have to notify the local authorities when someone moves into the town however; after someone has moved they do have to register within ten days.

Ms. Appleby stated that she understood it that the probation officers were to be notified within 30 days of someone planning to move. Deputy Mayor Turner stated that unfortunately the probation officer's are not obligated to inform local authorities.

Ms. Appleby stated that her issue is that the pedophile ordinance in the Borough is not being enforced. Ms. Appleby asked Attorney Cushing if it is his opinion that Borough Ordinances be enforced. Attorney Cushing stated that they should be enforced if they are enforceable.

Attorney Cushing explained that there are a number of cases in New Jersey that have set aside ordinances just like the Borough's. There have been legal issues raised. There are significant questions about the ordinances. Attorneys around the state have significant questions about the enforceability of these ordinances.

Attorney Cushing stated that he will provide Ms. Appleby with a copy of Judge Armstrong's opinion on this. Judge Armstrong's opinion states that in New Jersey, pedophile ordinances are preempted by the state regulations.

Deputy Mayor Turner suggested that it would be productive to draft a resolution backing Assemblywoman Marcia Karrow's position on this topic. Attorney Cushing stated absolutely. The Borough needs assistance from the legislature to help the Borough and every municipality in the state.

Councilman Higgins motioned to have a resolution drafted and have it circulated to every municipality in the state including the legislature and the Governors Office. Councilman Housel seconded this motion.

Roll Call: Higgins, Housel, Woykowski, and Turner.

Ayes: 4, Nays: 0 Motion Carried.

<u>Lilian Ortiz – 74 Lenape Trail</u>

Ms. Ortiz echoed many of the same sentiments as Ms. Appleby. She stated that she is a member of NJ Watchdog.com. She has found out that two pedophiles have moved into the Borough recently. She stated that she does not understand how the Borough can adopt an Ordinance and not enforce it. She wondered how the Borough can enforce a curfew ordinance when it cannot enforce a pedophile one.

Attorney Cushing explained that this case and Judge Armstrong's opinion has come down since the passage of this ordinance. In this case it may be best to go in another direction such as to petition the legislatures in Trenton. Citizens need to reach out to their legislatures to give municipalities the tools to enforce its laws.

Councilwoman Woykowski stated that Council has a committee established to work on this. She stated she is surprised that there is not some kind of a petition going around the State collecting signatures to put some pressure on our legislatures.

ORDINANCES:

Ordinance 7-2007 A Bond Ordinance Appropriating \$2,145,950.00 in Bonds or Notes of the Borough for Various Improvements or Purposes Authorized to be Undertaken by the Borough of Washington in the County of Warren State of New Jersey. (Final Adoption)

This Ordinance was introduced by Councilman Housel, seconded by Councilwoman Woykowski.

It was further moved by Housel, seconded by Woykowski that the Clerk read Ordinance 7-2007 by title.

The Clerk read by title only and stated that this ordinance had been published in the Star Gazette as required by law, a copy was posted on the bulletin board and copies available upon request from the Clerk's office.

Deputy Mayor Turner explained that due to the three absent Council members the final vote on the Bond Ordinance would have to be postponed until the August 7, 2007 meeting.

Deputy Mayor Turner opened up the public hearing portion of the ordinance to the audience for their questions or comments.

Hearing none, it was moved by Woykowski to continue the public hearing to the next Council meeting, seconded by Housel

Ayes: 4, Nays: 0. Motion carried.

Ordinance 8-2007 An Ordinance Amending Chapter 94 of the Washington Borough Ordinance Entitled "Borough of Washington Development Regulations Ordinance", and more particularly amending the Borough's Development Regulations Ordinance Section 94-79.1 Entitled AR-7 Age Restricted Residential Zone District." (First Reading)

Deputy Mayor Turner entertained a motion to introduce Ordinance #8-2007.

Ordinance 8-2007 was introduced by Councilwoman Woykowski.

It was further moved by Woykowski, seconded by Turner that the Clerk read Ordinance #8-2007 by title only.

Roll Call: Woykowski, Turner, Higgins, and Housel.

Ayes: 4, Nays: 0. Motion carried.

The Clerk read Ordinance #8-2007 entitled, "An Ordinance Amending Chapter 94 of the Washington Borough Ordinance Entitled "Borough of Washington Development Regulations Ordinance", and more particularly amending the Borough's Development Regulations Ordinance Section 94-79.1 Entitled AR-7 Age Restricted Residential Zone District."

Council Discussion: Deputy Mayor stated that the Planning Board had discussed this recently. The setbacks for decks were discussed at a Planning Board meeting and the applicant was fine with the setbacks. Deputy Mayor Turner stated he would like to table this until review of the Planning Board Meeting minutes from that time-frame.

The attorney for Regency at Washington stated that procedurally the Ordinance should be introduced and a discussion of the Planning Board minutes be part of the public hearing. He also noted that he does not recall that discussion as mentioned by Deputy Mayor Turner. He also stated that Regency at Washington has already gone through the Planning Board process and the site plan was approved. It was always intended that each unit was going to have a deck or a patio.

Councilman Turner stated that the Planning Board professionals stated that the applicant was told that the setbacks do not allow for decks.

The attorney for Regency passed out copies of the approved site plan as approved by the Planning Board. He stated that this was approved by the Planning Board. He stated he suggested that the ordinance be amended to permit what was already approved by the Planning Board. He can not believe that any professional or members of the Planning Board would not question what the blocks are on the site plan.

Councilman Turner stated he was only involved with the final approval of this project. He stated the Planning Board relies heavily on their professionals to double check these types of issues. He suggested that the Council introduce the Ordinance for a vote and send the Ordinance to the Planning Board for review. He stated that Regency contact Mr. Hintz to clarify the situation.

Councilman Higgins stated that he would also like to see input from the Fire Department on this issue since we are talking about elevated decks. The attorney for Regency stated that the decks would be three to four feet off of the ground.

Keith Gonzales on behalf of the Washington Fire Department stated that the department was not asked to look at the plans at all. He also stated that it is his opinion that all developers who develop in this town request an opinion from the Fire Department whether it is required or not.

Peter Ollis from Toll Brothers stated that Toll Bros. did receive a very detailed letter form the Fire Department. He also stated that there are a lot of properties on this development that comply with the setbacks; so there will be decks built. He stated that he is trying to eliminate having 88 taxpayers show up at a Board of Adjustment meeting to apply for a deck variance. He stated that he was at every Planning Board meeting; there was no specific mention of a deck in any review letter. How the entire situation has gotten to this point is illogical.

Deputy Mayor Turner stated he is just trying to figure out why there are two different stories. He stated he was elected to represent the entire Borough and have all of the information to make the proper decision.

It was moved by Councilman Housel, seconded by Councilman Turner that Ordinance 8-2007 be introduced on first reading.

ORDINANCE #8-2007

AN ORDINANCE AMENDING CHAPTER 94 OF THE WASHINGTON BOROUGH ORDINANCE ENTITLED "BOROUGH OF WASHINGTON DEVELOPMENT REGULATIONS ORDINANCE", AND MORE PARTICULARLY AMENDING THE BOROUGH'S DEVELOPMENT REGULATIONS ORDINANCE, SECTION 94-79.1, ENTITLED "AR-7 AGE RESTRICTED RESIDENTIAL ZONE DISTRICT"

BE IT ORDAINED BY THE MAYOR AND COMMON COUNCIL OF THE BOROUGH OF WASHINGTON, IN THE COUNTY OF WARREN, NEW JERSEY, that Chapter 94 of the Borough Ordinance entitled "Borough of Washington Development Regulations Ordinance," Section 94-79.1, known as the "AR-7 Age Restricted Residential Zone District," and more particularly Subsection 11(e) "Bulk Standards for Lotted Developments" "Rear Yard," is hereby amended as follows:

SECTION I

(E) Rear Yard. The minimum rear yard for any building shall be twelve (12) feet. The minimum rear yard for any deck attached to any building or any patio emanating from any building shall be four (4) feet.

SECTION II

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

SECTION III

If any article, section, subsection, paragraph, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

SECTION IV

This ordinance shall take effect immediately upon final publication as provided by law.

Ordinance 9-2007 AN ORDINANCE FIXING THE SALARY AND WAGES OF CERTAIN MUNICIPAL OFFICIALS AND REPEALING PORTIONS OF PRIOR INCONSISTENT SALARY AND WAGE ORDINANCES (First Reading)

Deputy Mayor Turner entertained a motion to introduce Ordinance #9-2007.

Ordinance 9-2007 was introduced by Councilman Higgins.

It was further moved by Higgins, seconded by Housel that the Clerk read Ordinance #9-2007 by title only.

Roll Call: Woykowski, Turner, Higgins, and Housel.

Ayes: 4, Nays: 0. Motion carried.

The Clerk read Ordinance #9-2007 entitled, "An Ordinance Fixing the Salary and Wages of Certain Municipal Officials and Repealing Portions of Prior Inconsistent Salary and Wage Ordinances."

Council Discussion – Councilman Housel asked about the salary ranges, and what the actual salary increases are. Manager Corica stated the broader the salary range; the more flexibility the Borough has. The increase on these salaries was only an increase at the top of the salary range.

Councilman Higgins asked if the pay raises were included in the adopted budget. Manager Corica clarified for Council that if someone were to leave their job and a replacement was hired; the salary could be offered at the low end of the salary range; as long as the person is being paid consistent with the salary range and the union contract if it is a union employee. This Ordinance has no impact on any union contract. This is being done as a matter of simplicity to consolidate them into one place instead of five ordinances. The salaries affected here are the non-union positions.

Councilman Turner asked if the Borough is obligated to give non-union employees the same rate of increase as the union employees. Manager Corica stated it would be detrimental to the moral of non union-personnel to give them less of a raise then the union personnel.

Deputy Mayor Turner entertained a motion to introduce Ordinance 9-2007 on first reading.

Ordinance 9-2007 was introduced by Councilman Housel and seconded by Councilwoman Woykowski.

<u>SECTION 2.</u> Salaries herein shall be payable at the rate fixed in equal bi-weekly installments. Wages shall be payable bi-weekly. Any annual salary may be re-calculated to an hourly wage for any position unless restricted by collective bargaining agreement. Any and all fees received by officials and employees of the Borough of Washington shall be paid unto the municipality.

<u>SECTION 3.</u> Any salary and wage ordinance adopted prior to the adoption of this ordinance with provisions inconsistent with the provisions of Section 1 of this ordinance shall, to the extent of any inconsistency and only to the extent of the inconsistency, be repealed.

- <u>SECTION 4.</u> In the event the position becomes vacant or no figure is listed, then the figures noted in the column with the heading "salary or wage range" shall be utilized by the appointing authority and any salary or wage paid within this range shall be deemed appropriate and valid.
- <u>SECTION 5.</u> An employee who has medical coverage under a spouse's health benefit plan and waives participation in the Borough of Washington health benefits program shall be compensated at the rate of \$1,000.00 annually prorated to compensate the employee for only those pay periods when the Borough is no longer obligated to make health benefit payments.
- <u>SECTION 6.</u> The Supervisor of Streets in possession of a valid Certificate as Certified Public Works Manager shall have added to their base pay \$6,000.00 per year to be paid bi-weekly.
- <u>SECTION 7.</u> A public works employee who works eight hours in one day out of title in a job classification with a higher salary or wage range shall be entitled to additional compensation for that day at the rate of his or her current rate of pay plus ten (10%) percent.
- <u>SECTION 8.</u> Part-time Municipal Court employees, not covered by collective bargaining agreements, shall be paid \$30.00 per call-out for court work performed when outside the normal business hours of the Borough of Washington Municipal Court Office.
- <u>SECTION 9.</u> An officer assigned to the Detective Bureau shall receive a stipend equal to \$40.00 per pay period, not to exceed \$1,040.00 per year.
- SECTION 10. An officer who has obtained an Associates Degree in Police Science, Public Administration or Organizational Management shall be entitled to \$500.00 incentive pay and an officer who has received a Bachelor of Science Degree in Police Science, Public Administration or Organizational Management shall be entitled to \$1,000.00 incentive pay. Incentive pay shall be added onto the employee's base salary.
- <u>SECTION 11.</u> A K-9 officer who is not provided with time off during his or her normal assigned shift for K-9 maintenance shall be compensated at the rate of \$16.00 per hour for 2006 and to the end of the contract term for K-9 maintenance duties up to a maximum of 5.25 hours per week.
 - SECTION 12. The rates contained herein shall become effective January 1, 2007.
- <u>SECTION 13.</u> In accordance with Chapter 3, Article II, Section 15, Subsection E of the Code of the Borough of Washington, this Ordinance shall become effective 20 days after final passage unless the Council, by an affirmative vote of five (5) Council Members, shall adopt a resolution declaring the Ordinance to be an emergency upon which said Ordinance will take effect upon final passage.

Councilman Turner also asked about the bike path study. He asked if a bike path is practical in the Borough. He stated that our money would be more wisely spent looking into other grants. Manager Corica stated that Council is not required to do this.

OLD BUSINESS:

<u>Policy Defining the Process of Professional Services Provided by all Appointed</u> <u>Professionals.</u>

Councilwoman Woykowski stated that there are perfect examples of resolutions provided by H2M that are on the agenda for this evening. These resolutions include the scope of services. This policy will empower the manager to get accurate information for resolutions. All resolutions will include a *not to exceed amount*. Deadlines will also be included in resolutions.

Attorney Cushing stated that this is very good however; this is the type of thing that a good manager will produce.

Councilwoman Woykowski stated this is a policy. As long as we have a good manager this policy will be easy to follow. Chances are we will never have to use number four and number five. Councilman Higgins stated that these items should be part of the manager's job description. Councilwoman Woykowski stated that in the past mistakes have been made in applying monies to a particular resolution. She also stated the resolution will be included in the bill list.
