Councilman Higgins questioned the status of the sod pertaining to the Recreation Commission's communication to the Governing Body. Manager Corica explained that the Borough Engineer has made several attempts by phone and by letter to contact the landscaper and Centex. Manager Corica indicated that he does have copies of the letters sent by the Borough Engineer.

Councilman Higgins questioned if the Borough Engineer is willing to accept responsibility if the sod is installed now and goes bad. Councilman Higgins stated that the Borough Engineer's response to the article attached to the Recreation communication is that the Borough is installing a hardier variety of sod and will be able to withstand the cold nights. Councilman Higgins stated that is a huge risk to take. Additionally, Recreation is concerned over the new water wheel freezing up. Manager Corica stated that given all of this it looks like the Borough is looking at a spring planting.

Manager Corica also pointed out to Council that Centex was ready to go and the Borough asked them to hold off until we had an adequate water supply.

Councilman Housel noted that if we hold off until spring the field will need to re-graded.

Mayor Van Deursen asked the Dawn Higgins, Recreation Chairperson what the commission would suggest doing at this point. Ms. Higgins stated that the Recreation Commission feels that due to the weather conditions the sod should be installed in the spring.

Council concurred that the sod planting should be held off until the spring of 2008. Mayor Van Deursen requested Attorney Cushing prepare a letter to Centex stating this decision and informing them that the Borough wants this sod installed by March or April of next year.

Councilman Higgins suggested contacting the local sod farms to inquire about the best time to install the sod.

Councilman Turner noted for the record that the Engineering firm has let us down again.

Mayor Van Deursen entertained a motion to acknowledge, receive and file the communications.

It was moved by Higgins, seconded by Oakley that the communication be acknowledged, received and filed.

Shared Services Committee: Councilwoman Woykowski presented the draft of Interlocal Agreement between the Township of Mansfield and the Borough of Washington regarding the street sweeper. If council agrees this will be sent to the Borough Attorney for review.

The Borough of Washington will provide the sweeper for maximum of 10 days throughout year. A schedule will be prearranged. Councilman Oakley questioned what will happen if gas prices go up? Manager Corica indicated that the agreement will be changed to reflect a one year agreement.

Councilman Housel voiced concerns over one of our workers being gone for ten days out of the year; if there is an emergency, who will replace them? Manager Corica stated that is part of the compensation. The Borough will control when the machine goes out. We can pull them back to the Borough if needed. Councilman Cioni stated he is in favor of this agreement. This is a give and take partnership and generates good faith.

Manager Corica explained that he and Councilwoman Woykowski wanted a consensus from Council prior to sending the agreement to the attorney for review.

Council concurred that the agreement be sent to Attorney Cushing for review and revised to reflect a one year agreement.

Attorney Cushing indicated that he will have a resolution and the agreement prepared for the next meeting.

Manager Corica also informed Council that the Borough Attorney will be drawing up an Interlocal Agreement between the School Board and the Borough for plowing of the schools.

Councilman Housel noted that the roads in the Borough must be the top priority for plowing.
