WHEREAS, the governing body of the Borough of Washington has established sewer rates based upon a projected budget for the year 2007; and

WHEREAS, the total appropriations for the 2006 Sewer Utility Budget, exclusive of any appropriations made for interest and debt redemption charges, and capital improvements, is the sum of \$963,464; and

WHEREAS, one fourth of the appropriations for the 2006 Sewer Utility Budget, exclusive of any appropriation made for interest and debt redemption charges, capital improvements is the sum of \$240,866.

Council Discussion:

Councilman Higgins stated he had several questions pertaining to the appointment resolutions including Resolution 4-2007. Councilman Higgins asked if the Borough is aware of what the bank fees are for the banks listed above. He also asked if the Borough is aware of what the professional's fees are for 2007.

Manager Sheola explained that the bank fees are covered by compensating balances. For example, the cost to do payroll is covered by increasing the Borough's compensating balance therefore there is no cost to the Borough. The Borough's primary bank is PNC Bank and the other banks are listed for investment purposes and there is no charge.

Councilman Higgins asked how the Borough would know that these banks are offering the best deal. Manager Sheola explained that the Borough Treasurer and the Borough Manager periodically review the banks. Changing lead banks would be a business decision that would be presented to Council if the need arose. Manager Sheola stated that this resolution basically allows the Borough to use the banks listed.

Councilman Turner asked Manager Sheola how often is the Borough reviewing the banks. Manager Sheola replied the banks are reviewed once a year. Councilman Higgins asked the Borough Manager how the Council is informed of the bank information. Councilwoman Woykowski suggested that this information be included in the Borough Manager's report. Manager Sheola indicated that it could be included in the Manager's Report when the banks are reviewed. If there was going to be a change in the designated banks it the information would definitely be presented to Council.

Councilman Higgins voiced his concern over voting on this item when Council is not sure of the bank fees. Manager Sheola indicated that he could not recall an instance where the Borough has had a service charge from a bank.

Attorney Cushing suggested that Councilman Higgins request from the Manager a short report on how the banks are used and what the charges are. Manager Sheola stated that the Borough just reviewed the banks in late summer of 2006 and decided to stay with the lead bank of PNC due, to the fact that they offer the best proposal with the highest yield and the lowest compensating balance.

Resolution #5-2007 – Interest Rates on Taxes

The following Resolution was moved by Housel, seconded by Higgins and adopted:

RESOLUTION #5-2007 INTEREST RATES ON TAXES

WHEREAS, municipal charges, namely taxes are payable in quarterly installments due on February 1, May 1, August 1 and November 1, and the installments becoming delinquent if not paid on or before those dates.

BE IT THEREFORE RESOLVED, that Council does hereby authorize an interest charge not to exceed eight (8%) percent per annum on the first \$1,500.00 of the delinquency and eighteen (18%) per annum on any amount in excess of \$1,500.00 upon all delinquent installments; and

BE IT ALSO RESOLVED, that Council does hereby authorize a penalty to be charged to a taxpayer with a delinquency in excess of \$10,000.00 who fails to pay that delinquency prior to the end of the calendar year. The penalty so fixed shall not exceed six (6%) percent of the amount of the delinquency.

BE IT FURTHER RESOLVED, that any installments received after the expiration of the grace period, and such grace period shall be the period starting with the second day and ending on the 10th day after the quarterly due date, shall bear interest at the applicable interest rate from the original due date.

BE IT FURTHER RESOLVED, that the Tax Collector of the Borough of Washington is hereby authorized to conduct the annual sale of delinquent municipal charges, namely taxes for the Calendar Year of 2006.

Resolution #6-2007 – Sewer Interest Charges

WHEREAS, municipal charges, namely sewer are payable in monthly installments due on

the 10th of the following month after billing, and the monthly installments becoming delinquent if not paid on or before those dates.

BE IT THEREFORE RESOLVED, that Council does hereby authorize an interest charge not to exceed eight (8%) percent per annum on the first \$1,500.00 of the delinquency and eighteen (18%) per annum on any amount in excess of \$1,500.00 upon all delinquent installments; and

BE IT ALSO RESOLVED, that Council does hereby authorize a penalty to be charged to a taxpayer with a delinquency in excess of \$10,000.00 who fails to pay that delinquency prior to the end of the calendar year. The penalty so fixed shall not exceed six (6%) percent of the amount of the delinquency.

BE IT FURTHER RESOLVED, that any installments received after the expiration of the grace period, and such grace period shall be the period starting with the second day and ending on the forty-fifth (45th) day after billing, shall bear interest at the applicable interest rate from the original due date.

BE IT FURTHER RESOLVED, that the Tax Collector of the Borough of Washington is hereby authorized to conduct the annual sale of delinquent municipal charges, namely sewer for the Calendar Year of 2006.

Council Discussion:

Councilman Turner asked the Borough Manager about the interest rates for sewer charges and how could it be possible for a residential home to have over \$1,500.00 in charges. Manager Sheola explained that it is unlikely a residential home would have charges over \$1,500.00; however these interest rates are Statutory for any municipal charge or tax.

WHEREAS, there exists a need for legal services to be rendered to the Borough of Washington, Warren County, New Jersey; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et. seq.) requires that the Resolution authorizing the award of contracts for professional services without competitive bidding must be publicly advertised.

NOW, THEREFORE, BE IT RESOVED, by the Mayor and Common Council of the Borough of Washington, Warren County, New Jersey as follows:

- 1. That the Mayor and Common Council are hereby authorized to execute the appointment of Richard P. Cushing of the firm of Gebhardt & Kiefer, Municipal Attorney, as outlined in Article VI, Department of Law S3-40 of the Borough Code adopted by the Borough of Washington January 8, 1974.
- 2. This appointment is made without competitive bidding as professional service under the provisions of the Local Public Contracts Law because:

"The service to be rendered by the Municipal Attorney can only be rendered by a person that meets the qualification standards of the New Jersey State Bar and is further subject to the rules and procedures of the courts of the State of New Jersey; and further, the services which are of such a qualitive nature as will not reasonably permit the drawing of specifications for the receipt of competitive bids." 3. Council Discussion:

Councilman Higgins asked Council and the Borough Manager if Request for Proposals had been obtained for this years professional appointments.

Mayor Van Deursen stated that customarily the Council will decide if they would like to go out for RFP's earlier in the year. Councilman Higgins stated that the Council should be looking to start a policy of requesting RFP's from all of its professionals. Councilman Turner stated he would like to start seeing RFP's because the Borough has not seen any in recent years.

Councilman Higgins asked if the professionals who are being reappointed are being reappointed at the rates of last year. Attorney Cushing explained that the Attorney's fees customarily go up 3% a year.

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et. seq.) requires that the Resolution authorizing the award of contracts for professional services without competitive bidding must be publicly advertised.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Common Council of the Borough of Washington, Warren County, New Jersey as follows:

- 1. That the Mayor and common Council are hereby authorized to execute the appointment of **Roger J. Skoog, Municipal Prosecutor**, whose duties shall be as outlined in Article VI, Department of Law, S3-40 of the Borough Code adopted by the Borough of Washington on January 8, 1974 and P.L. 1996, C. 95, Section 14, together with such additional legal sources as may be authorized by the Mayor and Council.

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:1-1 et. seq.) requires that the Resolution authorizing the award of contracts for professional services without competitive bidding must be publicly advertised.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Common Council of the Borough of Washington, Warren County, New Jersey as follows:

1. That the Mayor and Common Council hereby appoint Scott Wilhelm, Esq. **Municipal Public Defender,** as provided for in P.L. 1997, Chapter 2356 and in accordance with Chapter 3, Article VI, S3-41.1 of the Code of the Borough of Washington.

2. This appointment is made without competitive bidding as a professional service under the provisions of the Local Public Contracts Law because:

"The service to be rendered by the **Municipal Public Defender** can only be rendered by a person that meets the qualification standards of the New Jersey State Bar and is further subject to the rules and procedures of the courts of the State of New Jersey; and further, the services which are of such a qualitative nature as will not reasonably permit the drawing of specifications or the receipt of competitive bids.

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et. seq.) requires that the Resolution authorizing the award of contracts for professional services without competitive bidding must be publicly advertised.

NOW, THEREFORE, BE IT RSOVLED, by the Mayor and Common Council of the Borough of Washington, Warren County, New Jersey as follows:

- 1. That the Mayor and Common Council are hereby authorized to execute the appointment of the firm of Suplee, Clooney, and Company as Municipal Auditor, as outlined in Chapter 7, Section 5:6 of the Administrative Code adopted by the Borough of Washington on January 2, 1969.
- 2. This appointment is made without competitive bidding as a professional service under the provisions of the Local Public Contracts Law because:

"The services to be rendered by the Municipal Auditors are of such a qualitative nature and will not reasonably permit the drawing of specifications of the receipt of competitive bids."

Councilman Turner asked if this was the only proposal received by the Borough. Mayor Van Deursen stated that the Borough Council had decided to request proposals for Municipal Auditors every five years.

Resolution #12-2007 – Waste Water Consultant

Council Discussion:

Councilman Turner stated that he has a large concern over Hatch Mott McDonald holding four positions in the Borough.

Councilman Higgins stated he would prefer Hatch Mott McDonald stay on as Waste Water Consultant due to the fact that we have dealt with them for many years.

Councilman Turner said the Borough should have gone out for RFP's on this position. Councilwoman Oakley agreed with Councilman Turner stating having one company hold four positions in the Borough is not a good idea.

Councilman Housel stated he would prefer to stay with Hatch Mott McDonald because they are a premiere engineering firm and they know the sewer system in great detail.

Mr. Sherman stated that it is not. Mr. Sherman stated that he had called Verizon several times in regards to the issue. It seems that all Verizon has at the end of the parking lot is a filled in drywell that does not allow water in. The storm-water seeps onto the properties in Gardner's Court.

Attorney Cushing stated that the Borough may have jurisdiction if their site plan required some type of maintenance of the storm-water retention facility.

Mayor Marianne Van Deursen suggested to Mr. Sherman to schedule a meeting with the Borough Manager, Richard Sheola to investigate the issue further.

Mr. Sherman also stated that there is also a sanitary issue at Gardner's Court and questioned if the Borough is looking into the issue. Manager Sheola stated that the Borough is working towards a resolution on the issue. Mr. Sherman stated that every three months he

is getting sewage in his basement. Mayor Van Deursen suggested that the sanitary issue be a part of the conversation with the Borough Manager.

Councilman Turner asked Mr. Sherman when the sanitary problem first started. Mr. Sherman stated the problem began the third weekend he lived in the house and he has owned the home for $3\frac{1}{2}$ years.

Hearing no further remarks, it was moved by Higgins, seconded by Turner that the audience portion of the meeting be closed.

Councilman Turner stated he is very unhappy about the fact that Mr. Sherman has been having a sanitary issue for over three years and no one from the Sewer Plant has informed Council on these issues.

Councilman Higgins asked about the D.P.W. garage design plans. Manager Sheola gave a brief history on the D.P.W. project up to this point. Councilman Higgins asked why the Borough is looking at redesigning the garage. Manager Sheola stated that there was no cost to meeting with this contractor for the redesign suggestions.

Councilman Cioni commented that it is a common thread that the bids are coming back much higher than the money the Borough has allocated. Councilwoman Oakley stated that particular issue was addressed several months ago and is continuing to be addressed.

Councilman Higgins voiced concerned over the meeting with the contractor for redesign suggestions. Councilman Turner explained that originally the Council wanted a Morton type building.
