Mayor Van Deursen entertained a motion to acknowledge, receive and file the communications.

Councilwoman Woykowski noted communication number five. She stated that the Borough should request from the other municipalities their feelings on the topic prior to the Borough adopting a Resolution. Jim Sheldon, Bid Director stated that Karen Williamson from the Heritage Conservancy is presenting in Washington Township this evening; Jim will contact her to gather additional information. Mr. Sheldon will provide additional information to the Council. Council agreed to have Karen Williamson present to Council the second meeting in March.

### **AUDIENCE:**

Dawn Higgins, Recreation Chairperson read a prepared statement to Council. The statement is as follows:

As the events of the past several weeks have unfolded it has become increasingly clear to me what my course of action should be. I have looked at my almost nine years with Recreation Commission as a labor of love. I with my fellow Commissioners have put in countless volunteer hours to improve services for our Community. We have planned permitted and executed many diverse programs such as: Free Concerts, Baseball/Softball Tournaments, Revivals, Fourth of July Floats, Military Band Concerts, Men's Basketball Tournaments, and Nine Sports programs. The Recreation Commission has added new programs such as the battle of the bands, children's day event, holiday house decorating contest, tree lighting with Santa and movie, and movies in the park. The Recreation Commission also developed and administered the annual budgets, hired personnel as needed for the park, ordered equipment and supplies as needed, administered Borough policies, made repairs on our own dime, patrolled the park after hours, developed and executed plans for the new pool project, and developed and presented plans for the Railroad Avenue project.

We provided the same level of programming and more while, I can say proudly, staying within the budget that has been consistently cut for the past five years.

I have availed myself to the many workshops and training that was offered by the New Jersey Recreation and Parks Association. I initiated the use of the Association as a resource for the Commission. I attended local district meetings and met many professionals who admired the fact that we do their job for free.

As the recent Chair of the Commission I made it my goal to keep the council in the loop of all the activities of the Commission. I took an active role in dealing with the many projects going on at the Park. For instance, when Lucas Electric damaged the field on the first day of construction I had them come back to the field to fix the damage. I worked closely with our vendor to install new playground equipment. I visited the Township for a demonstration of the new watering system for Vara Field, before we purchased one for the Borough. I am in constant contact with T & M Assoc. regarding the pool project. Our relationship with T&M is good but I will tell them when they are wrong. I was the one who told them the Borough is not paying for additional grounding work. I expressed my displeasure when a change order was not done properly and yet we continue to have good open communication despite some bumps in the project.

It is in vein that I must address my future with the Recreation Department of the Borough. It is imperative that a successful working relationship have honesty, trust, and good communication. In recent weeks, Council has moved to abolish the Recreation commission. It is puzzling to me why you chose to do this move in secret and not include the Recreation Commission from the onset. To compound that you have made comments that insult the very definition of the word volunteer.

"Volunteers shouldn't tell paid employees what to do." "They (the Commission) don't have the professional training to do the job." "If you quit that would be selfish and hurt the town and the kids." "Why is it so important to have control of the money if you're doing it for the kids?"

These comments and others are a slap in the face for every hour of volunteer time that was spent on the Commission. Considering the fact four out of the six Commissioners don't have children in the programs.

With the recent actions and story lines, coupled with the manner in which you executed the vote on January 29, 2008, has left me no confidence that you will work with us in a forthright manner. I cannot continue with a severed relationship, so I will be stepping down from my duties as a Recreation Commissioner effective immediately.

Mayor Van Deursen stated she was sorry to hear that Ms. Higgins was stepping down. She has contributed much to the community and all of Council is very grateful.

**Sewer Committee:** Councilman Higgins stated the sewer committee met and reviewed the H2M report. The sewer committee is recommending no conditional approvals on sewer capacity by the Planning Board. Councilman Turner stated that the new Planning Board Engineer is well aware that we no longer want conditional approvals. Councilwoman Woykowski commented that if there are conditionals granted; we need to have them attached to the Ordinance. Councilman Higgins asked Attorney Cushing if this will require an Ordinance change. Mr. Cushing explained that most Zoning and Planning Boards have a check list which is adopted by Ordinance by the Governing Body. Mayor Van Deursen stated the Planning Board is reviewing the check list document now. It will be presented to Council for adoption.

Councilman Higgins stated that the sewer treatment facility has not yet reached 80% capacity which would require a plan by the D.E.P; however it is the committee's recommendation that one be adopted prior to hitting the 80% mark. It should be noted that Warren Hills High School and the Acme Plaza are hooked into the Borough sewer system. Council discussed the nee to re-evaluate what is going on at the High School concerning additions. How is the Borough informed that their usage is going up? Manager Corica will review six months of water bills from the schools. Manager Corica also stated a procedure needs to be established with Washington Township for notifying the Borough in situations like this. Attorney Cushing stated that the Sewer Ordinance addresses this topic. The Ordinance stated that the water usage should be reviewed every five years.

Councilman Higgins also cautioned Council that if the sewer permit changes to 1.1 the Borough will have no additional sewer capacity.

The committee also discussed the situation at Gardner's Court. A plumber suggested installing a gated ball valve in the lines. This will allow the two homeowners affected to manually close the line and prevent back ups into the home. Councilman Higgins stated it is the least expensive way to temporally solve the issue. The cost of the valves in both homes will be \$1,500.00.

Councilman Higgins motioned for the Borough paying for the installation of the valves, seconded by Councilman Housel by either having a written agreement with the homeowner or having the homeowner hire a contractor to install the valves and letting the Borough pay for it.
