BOROUGH OF WASHINGTON, WARREN COUNTY, NEW JERSEY WASHINGTON BOROUGH COUNCIL MINUTES – December 16, 2008

The Regular Meeting of the Borough Council of Washington, Warren County, New Jersey was held in the Council Chambers of Borough Hall at 7:30 P.M.

Mayor Van Deursen led everyone in the flag salute.

Mayor Van Deursen read the following Statement into the Record:

"The requirements of the 'Open Public Meetings Law, 1975, Chapter 231 have been satisfied in that adequate notice of this meeting has been published in the Star Gazette and posted on the Bulletin Board of Borough Hall stating the time, place and purpose of the meeting as required by law.

COUNCIL APPEARANCE

Andrew Holt – Municipal Engineer

Mr. Holt stated that as the new municipal engineer the firm spent the year learning about the Borough and doing a lot of fact finding this year. He stated he has office hours on a regular basis which enables him to have interaction with the staff and attend weekly meetings with the Borough Manager. He stated he worked with the Borough Clerk to re-structure the fees and the ordinances regarding street opening permits. He stated he also attended the redevelopment meetings.

The Public Works facility was a high priority this year. There have been a few weather related delays. The contractor is still on schedule for spring completion. The Municipal Parking lot project was also a high priority. He has been working with the Borough and the DEP on the environmental liabilities. He has been working with the Business Improvement District to facilitate its construction. The demolition of Modern Valet is scheduled to begin after JCP&L removes some wires going into the building. The Stormwater Management Plan and annual report for the Borough is in full compliance and the tax maps have been updated some for the newer developments.

Mr. Holt stated that he also spent the year learning the Borough's sewer system. He is recommending that next year the Borough install flow metering throughout system. The manhole inserts will be installed shortly.

Mr. Holt stated that overall he hopes that he hopes Suburban Engineering met the expectations of the Borough or exceeded them.

Mayor Van Deursen stated that Mr. Holt is one of the most competent and thorough professionals that Borough has and she has thoroughly enjoyed working with him. Councilman Turner stated he is impressed by the way you handled deficiencies.

Kurt Klausfelder – Borough of Washington Fire Chief

Mr. Klausfelder stated that currently the Fire Department is staffed by 47 active members and 6 junior members. One of the junior members has turned 18 and attended the Warren County Fire Academy this year, where he received the most improved firefighter award at graduation.

He explained that this year the Fire Department has trained in live burn structural firefighting evolutions, fire attack, hose line advancement, fire extinguishers, flashover training, live burn vehicle firefighting evolutions, forcible entry, ventilation, as well as many other training exercises. Most of the training took place either in house with acquired instructors or at the Warren County Fire Academy. He stated that in the department, they are fortunate enough to have five New Jersey State Certified Fire Service Instructors. Also, this year the department received training from Lt. Bill Butler from Truck 56 FDNY. The amount of time the department spent training this year was 164 hours.

Mr. Klausfelder stated that the fire department received the Assistance to Firefighters Grant awarded through FEMA in the amount of \$375,000. In years past the fire department has been successful in getting funds through this grant on two other occasions. The odds of being awarded a grant are a long shot at best.

Our members have been successful three times. This is money that the fire department has raised on its own and has not had to request from the taxpayers. Mr. Klausfelder explained that over the past three years in his budget request he has listed the replacement of the 1975 ladder truck and the approximate replacement cost to be about \$1,000,000. In March of this year, Council voted to move forward with the truck project. At that time we also informed Council that we were trying to obtain some financial assistance through a FEMA grant. A truck committee was appointed to gather the require3d information to outline the specifications of the truck needed to best serve the community. The 1975 Mack Aerial scope has served the Borough well but so much has changed in our community since then. Many or our current apartment buildings and garden apartments did not exist at that time, they present reach problems due to landscape and or parking issues. We also did not have the Toll Brothers or Midtown projects which also present reach problems. Over the years we have had to make a risk vs. benefit decisions at structure fires regarding the placement of the truck.

It is the Fire Departments hope that the bid for the new ladder truck will be awarded before the end of this year. This would greatly help with u s being able to meet deadlines for the truck delivery date, instituted by the grant.

Mr. Klausfelder reported that the fire department has responded to 184 calls this year. By filing reports with the Division of Fire Safety we are able to track the number of calls, types of calls, hours on scene and response time. The average amount of time spent on scene is about an hour, and has a typical manpower response of 10. We are down 10 calls from this time last year. Overall average response time is still approximately 8 minutes 24 seconds. Most career departments are between 4 to 5 minutes response time. Considering we have to drop what we are going and respond. On several occasions this year the fire department has also responded to assist the rescue squad as well as the police department. We have a great relationship with both agencies and are glad to assist them anytime our services and tools are needed.

Mr. Klausfelder stated he would like to thank the Mayor, the Manager and the members of this Council for all the support, help, and guidance they have provided over t5he past three years. I have one year left to serve as chief and I plan to continue to make our fire department better trained, better equipped, and better prepared to serve the future needs of our community and residents.

Kay Stasyshan – Tax Collector

Ms. Stasyshan stated this was a busy year for collection services in the tax office. The office continues to learn and work with the new finance system. This year the Borough sent out an estimated third quarter tax bill which was confusing to some taxpayers. The tax sale consisted of 81 properties this year mainly due to the economy. There were three properties struck off to municipality. The tax collection rate is 95.5%.

Sharon Cooper Brown and Brown

Ms. Cooper stated that several months ago she appeared before Council informing them that the three year term with Statewide was up and the end of 2008. She suggested at that time that the Borough look into receiving proposals from Statewide and Public Alliance. Councilwoman Woykowski asked if it will be another three year obligation. Ms. Cooper stated yes both companies are three year obligations. Councilman Higgins noted that there is a meeting on December 29 and Council can consider the recommendation at that time. Manager Corica stated the advantage to Statewide is that the Borough has been with them for a very long time. The advantage to PAICE is that they insure 381 municipalities. The premiums are comparable. PAICE is more financially stable. Councilman Higgins inquired what the commission for MS. Cooper is under Statewide compared to PAICE. Councilman Higgins requested the commission information be forwarded to Council.

Caroline Comby Administrator of Statewide Insurance Fund

Ms. Comby stated that the Borough of Washington has been a member of the Statewide Insurance fund since its inception in 1988. She stated in terms of coverage; law enforcement is separate and defense costs are outside the limit however with PAICE it is inside the limits. She explained that a sample policy and procedures manual was done and sent out over a year ago. Statewide also developed a website to keep track of all training. Manager Corica inquired about dividends and the closing out of fund years. He also noted that the premium payment structure in Statewide is difficult for municipalities due to the fact the entire premium is due in the beginning of the year. Municipalities are only working off of a temporary budget at that time. Ms. Comby stated she will bring Mr. Corica's concerns back to the executive committee.

Hearing no further comments from the audience a motion was made by Oakley, seconded by Cioni to close the audience portion of the meeting.
