COUNCIL APPEARANCE

Rudy Bescherer - Zoning/Code Enforcement

Mr. Bescherer reported that through the course of his normal duties he processed zoning permits, received numerous calls regarding zoning. He also issues warnings when there are violations on local ordinances and issues summonses. In 2008, he received 296 complaints and did 207 investigations. He issued 414 warnings and issued 116 summonses. Additionally he received 30 complaints from various businesses on zoning issues. He reported that he received 119 zoning applications of which 24 were denied and referred to either the Planning Board or Board of Adjustment. He also issued 42 on street overnight parking permits. The community service workers worked throughout the community cutting grass, raking leaves, painting curbs, and shoveling snow. These workers performed 951 hours of community service.

Mayor McDonald thanked Mr. Bescherer for his continued service to the community.

The Recreation Director never attended a meeting and grievances were not addressed with the Borough Manager. Standards were lowered for lifeguards and swim instructors. Mr. Feldman stated the new filtration system does not work properly. Mr. Feldman asked who will be responsible. As the Recreation Committee begins its 2nd year, we still have no liaison. Mayor McDonald asked Mr. Feldman to provide him with a list of his concerns so that he can address the issues as time goes on.

Councilman Housel noted that the previous manager's report indicated that the filtration system was fixed. The Borough Clerk will check on this and look into the performance bond of the company.

WHEREAS, the governing body of the Borough of Washington on June 4, 2003 adopted Ordinance 7-2003 creating the Washington Borough Special Improvement District; and

WHEREAS, the governing body of Borough of Washington designated the Washington Borough Business Improvement District Management Corporation as the District Management Corporation for the Special Improvement District; and

WHEREAS, the Washington Borough Business Improvement District Management Corporation Board of Directors have approved a 2009 Business Improvement District Budget for submittal to Borough Manager for submission to the Mayor and Council of the Borough of Washington for their consideration; and

WHEREAS, pursuant to N.J.S.A. 40:56-80 and N.J.S.A. 40:56-84, the governing body of Borough of Washington is required to approve the budget and fix the time and place for the holding of public hearing upon the budget; and

WHEREAS, the governing body of Washington Borough has determined that at least ten days prior to the hearing a complete copy of the proposed budgets shall be: (a) posted on the bulletin

board in the Borough Municipal Building; (b) made available to each person requesting the same before and during the public hearing; (c) a copy of the budget shall be advertised along with the date, time and place of the hearing in a newspaper published in the county and circulating in the municipality at least 10 days prior to the hearing; and (d) the hearing shall be held not less than 28 days after the approval of the budget.

NOW, THEREFORE, **BE IT RESOLVED**, the governing body of the Borough of Washington that:

- 1) The Washington Borough Business Improvement District budget is hereby introduced and approved by the governing body of the Borough of Washington for the period of January 1, 2009 December 31, 2009 in the amount of \$254,357.
- 2) The hearing on the Washington Borough Business Improvement District Budget shall be Tuesday, March 3, 2009;
- A special assessment in the amount of \$200,000 will be imposed and will be collected with either the regular tax payment (or payment in lieu of taxes), or otherwise, on properties located within the Borough of Washington as set forth within Ordinance 7-2003 as amended from time to time and the assessment proposed will be determined by the Borough Assessor;
- 4) Payments received by the Borough of Washington for the District will be transferred to the Washington Borough Business Improvement District Management Corporation to be expended in accordance with the approved budget;
- The Borough Clerk will be authorized to forward a certified copy of the adopting resolution to Washington Borough Business Improvement District Management Corporation, the Warren County Board of Taxation, and the Director of the Division of Local Government Services in the State of New Jersey Department of Community Affairs after the public hearing and adoption by a majority vote of the full membership of the governing body.

Councilman Housel stated he wants to see a five year plan from the BID and has also requested a professional business plan. Bid Director Sandy Cerami stated that the professional business plan is in the process of being developed by the marketing group hired by the BID. The report is forthcoming. Ms. Cerami stated that she will be prepared to present the annual report and the five year plan will be presented to Council at the next meeting.

- **WHEREAS,** there will be a period of time between February 1, 2009 and when the new Manager is appointed; and
- **WHEREAS,** it is necessary and desirable that the Borough have an Acting Manager until a new Manager is appointed; and
- WHEREAS, Kristine Blanchard, the Municipal Clerk, is extremely competent and capable and has the abilities and qualifications to fulfill the duties as Acting Manager; and
- WHEREAS, Kristine Blanchard has filled the position of Acting Manager in the past; and
- **WHEREAS,** Section 3-19B of the Code of the Borough of Washington provides that the Manager may delegate to a qualified employee of the municipality the authority to perform his duties during his temporary absence or disability; and
- WHEREAS, the retirement of the Manager does not meet the criteria of a temporary absence or disability so that the outgoing Manager does not have the authority to make this appointment; and
- **WHEREAS,** the outgoing Manager has, in fact, recommended that Kristine Blanchard be appointed the Acting Manager based on her skills, experience, and qualifications; and
- WHEREAS, it is in the best interest of the Borough of Washington to appoint Kristine Blanchard as the Acting Manager until such time as the Borough appoints a new Manager or makes alternate arrangements for the position of Acting Manager.
