WHEREAS, without a 2009 certified tax rate the Tax Collector of the Borough of Washington will be unable to issue 2009 tax bills on a timely basis;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Washington, as follows:

- 1. The Tax Collector of the Borough of Washington is hereby authorized and directed to prepare and issue estimated tax bills for the Borough of Washington for the third installment of 2009 taxes. The Tax Collector shall proceed and take such actions as are permitted and required by Chapter 72, Public Laws of 1994 and N.J.S.A. 54:66.2 and 54:4-66.3.
- 2. The entire estimated tax levy for 2009 is hereby set \$ 16,209,341.06.
 - a. The estimated tax rate for 2009 Regular Taxes is hereby set at \$4.331.
 - b. The estimated tax rate for 2009 Special Improvement District I is hereby set at .264 (+ 4.331=4.595).
 - c. The estimated tax rate for 2009 Special Improvement District II is hereby set at .166 (+ 4.331=4.497).
