The Regular Meeting of the Borough Council of Washington, Warren County, New Jersey was held in the Council Chambers of Borough Hall at 7:30 P.M.

Mayor McDonald led everyone in the flag salute.

Mayor McDonald read the following Statement into the Record:

"The requirements of the 'Open Public Meetings Law, 1975, Chapter 231 have been satisfied in that adequate notice of this meeting has been published in the Star Gazette and posted on the Bulletin Board of Borough Hall stating the time, place and purpose of the meeting as required by law.

MINUTES:

Mayor McDonald entertained additions or corrections to the minutes of the Regular Meeting held September 1, 2009.

The Borough Clerk noted several changes presented by Councilwoman Gleba.

Hearing no further changes, it was moved by Boyle, seconded by Gleba that the minutes be approved.

COUNCIL APPEARANCE:

<u>John Burd – Department of Public Works</u>

Mr. Burd suggested to Council that they consider oil and chipping the Borough roads next year that are in need. Councilman Higgins asked what the cost difference is

between oil and chipping and blacktop. Mr. Burd stated that blacktop is approximately \$7500.00 and oil and chipping is much less expensive. Mr. Burd explained that the oil and chipping lasts for about two years. Councilman Cioni commended Mr. Burd and his staff on how fantastic the Borough Park looked this year. They did a fantastic job. Councilman Boyle asked Mr. Burd if everything was in order for snow plowing this year. Mr. Burd stated they may have some trouble; they are short one worker and have also taken on the school responsibilities as well. Mr. Burd stated they may have to let the alleys go this year. He stated there are several options that need to be explored such as the use of volunteers and contractors.

Mayor McDonald thanked Mr. Burd for his presentation.

Councilman Higgins noted Mr. Lowcher's client is requesting a right of way at Block 61 Lot 10. Manager Phelan stated that if this is Council's desire everything could be addressed in a Resolution. Councilman Higgins motioned that Manager Phelan reach out to Attorney Lowcher for more information, seconded by Councilwoman Gleba.

AUDIENCE:

Mary Finnegan 23 Youmans Ave

Ms. Finnegan stated that earlier in the year she had come before Council to introduce the idea of a Washington Borough community garden sponsored by the Key Club. Ms. Finnegan handed out additional information to Council outlining the site. She explained the garden would be directly in front of the Washington Garden Apartments. About eighty five garden plots could be created. The first year twenty to thirty plots would be created. Each participant would have to sign an agreement outlining the general rules and pay a fee of \$25.00 to \$30.00. Ms. Finnegan stated she has received an estimate from the water company of \$3700.00 for installing the water line. This would be the biggest expense in addition to fencing. Ms. Finnegan explained that she is hoping to cover the expense of fencing through a number of ways. Either through discounted pricing, donations, grant opportunities, and Key Club funds. Ms. Finnegan stated they are also creating an advisory board to assist the Key Club. Members recruited so far include

Christina Woykowski, Gary Pohorley, Gary Detrich, and Barbara Rose. She also stated that Rutgers University expressed an interest in doing an educational piece on the garden when it is completed. Ms. Finnegan stated that this project has numerous benefits for the community and would be a positive for the Borough through the reduction of food budgets and the conservation of resources. Ms. Finnegan stated she has discussed the project with the recreation committee and the park director endorses the project. The recreation committee will be sending a representative to the advisory board meetings. Ms. Finnegan asked if anyone from Council would be interested in joining the advisory board. Councilman Boyle stated he would join the board and it may also be beneficial that he is a member of the Rotary Club as well. Ms. Finnegan stated that would be extremely helpful. Ms. Finnegan stated that she is looking for a committed interest from the Governing Body. Manager Phelan stated he has reached out to the Insurance company regarding the liability and is waiting to hear back. Ms. Finnegan asked if the commitment from the governing body could be memorialized in the form of a resolution of the Governing Body at the next Council meeting. Christina Woykowski stated that she had done some research and has found out the USDA fully supports this kind of project and is offering grants and technical assistance. They also have individuals in all states that are master gardeners. This would be a good person to invite to an advisory board committee meeting. Mayor McDonald stated the Borough does need to make sure we are protected; but we do support what you have and once we have the information from the insurance company we can go forward with the resolution. Councilwoman Gleba commended Ms. Finnegan for doing her homework prior to her presentation.

Tom Bray 176 Broad Street

Mr. Bray stated that he has a concern regarding the property at 103 Broad Street. This property has fallen into disrepair and is an increasing eyesore in the neighborhood. He also stated that this is an income producing property and he would like to know how the town could let this happen. Mayor McDonald stated that he would have the Borough Manager address his concerns. Mr. Bray also complimented the town on the great job they are doing downtown.

Vince Smith Johnston Street

Mr. Smith inquired about the status of any capital projects planned for the roads within the borough. He stated that every road in this town is getting worse. Grand Avenue is terrible along with Warren and Stewart St. Councilman Cioni stated that all capital projects have been put on hold due to the costs. Mr. Smith stated the town needs to look into tarring and chipping some of these roads before they get worse. Mr. Smith also commented on the town not snow plowing the alleys. People use the alleys to park their cars during a snow storm. If the town is not going to plow the alleys how do they expect emergency vehicles to get through. Mr. Smith also commented on the police merger. He feels that this should have been brought to the people of the borough for a vote. Mayor McDonald explained that one of the reasons the people elect the Council is to do these types of these things and make efficiencies in government as best as they see fit.

Dana Mosk 68 Lenape Trail

Ms. Mosk stated that in 2006 she purchased her property. At the time of the purchase she had been under the impression that the fence and the shed existing on the property had been approved by the town. She has since been told that she needs permission to keep the shed. She is bringing this to Council's attention because she keeps getting letters in the mail and is concerned about the possibility of litigation. Manager Phelan explained to Ms. Mosk that her property is one of five with the same issue. Once all five properties are heard from he will let her know the date that council will take action.

Councilman Housel stated that he does not think anyone is happy with this budget. Mr. Ferry, Mayor McDonald, Manager Phelan, and Ms. Blanchard went to Trenton to petition the State of New Jersey for extraordinary aid. We were told that we would not receive the entire amount that we were asking for; however the Borough received the entire \$550,000. He stated he is not happy with the budget but we are between a rock and a hard place. Councilman Higgins asked if there was going to be anticipated surplus in this budget. Manager Phelan stated he anticipates \$180,000. Manager Phelan explained that cuts were made to the budget and a surplus of between \$150,000 and \$200,000 are anticipated. This money will be used to offset next year's budget. Mr. Ferry explained that having surplus or a fund balance is like having a savings account. The bigger the fund balance, the more cash you have on hand; this helps with the peaks and valleys of the tax collection times.

Councilman Housel asked if the budget doesn't pass; how soon will we have to reintroduce another budget. Manager Phelan said the Borough would need to re-introduce next week and it will have ramifications regarding added assessments and the timely mailing of tax bills.

Councilman Cioni noted that he has been a part of this process for six to nine months now. Discussions were had with Manager Corica and with Acting Manager Blanchard regarding the cuts that have all been implemented. It will be irresponsible to not adopt this budget. Councilman Higgins stated he disagrees and does not feel it is irresponsible.

Councilman Higgins asked where the Council stands with the request for proposals. Manager Phelan stated that a list of professionals will be prepared for the workshop meeting on September 29th. He also asked how many hours the new CFO will be working. Manager Phelan stated fifteen hours per week.

Councilman Boyle requested a resolution thanking the members of the Fire Department for all of their hard work in obtaining the grant received from FEMA for the purchase of the new fire truck. Motion made by Boyle, seconded by Cioni and approved.

Mayor McDonald stated that this is not the forum for the Governing Body to work out personal problems with one another. He requested that Council please respect each other when debating issues.

Hearing no further business to come before Council, it was moved by Housel, seconded by Boyle that the meeting be adjourned at 10:15 p.m.
