Mayor McDonald led everyone in the flag salute.

Mayor McDonald read the following Statement into the Record:

Councilman Boyle stated that the proposal for Pleasant Valley Mill Dam should state not to exceed \$26,000. He stated that he would also like to see something that stated we must do this. Manager Phelan stated that we need to move on this or the Borough could be fined upwards of \$5,000.00 per day. Manager Phelan also explained that this money is coming out of capital monies not current fund money. Councilman Higgins asked for a breakdown of hours for the project.

Councilman Higgins made a motion to approve the Resolution Supporting the Establishment of the Route 57 Scenic Byway Committee with Warren County as the Lead Agency.

#### PUBLIC HEARING ON 2010 INTRODUCED MUNICIPAL BUDGET

Kathy Halpin 86 Carlton Avenue

Ms. Halpin stated that the Borough has invested a lot of money into the pool. If Council decides to close the pool; we will lose continuity of having people join the pool and attracting businesses to the town. She stated in Hackettstown the swim team participants must join the pool in order to participate. Mr. Masenior has been doing a lot of good work in the park. She asked Council to reconsider closing the pool.

Beth Uporsky 281 Wyoming Avenue

Ms. Uporsky stated that she was very surprised that Council would consider closing the pool this late in the spring. The Recreation Committee has collected revenues already. If the swim team pulls out of the schedule at the last minute it will cost the swim league. It will also send a far reaching message that Washington Borough is no longer a viable town. She stated we have eight teams playing at the stadium this year. The stadium will have more people in it than in decades and we show them a dead dry pool. Ms. Uporsky stated that in order to save the pool she has organized a pool advocacy committee. The first action of the committee will be to reduce the pools drainage of the revenue from the Borough with expanded user fees, grants, and corporate sponsorships. She stated that she hopes that members of the council will join our advocacy committee and reconsider keeping the pool open. The advocacy committee is prepared to move quickly to bring in an action plan.

Councilman Cioni asked if an action plan can be prepared by the next Council meeting. Council concurred to postpone their decision pending the proposed action plan.

#### Edna Detlefs 27 Fisher Avenue

Ms. Detlefs asked the status of the forensic audit. Mayor McDonald stated it is in the introduced budget and the submission date for responses is April 27.

#### Ken Chambers 64 Grand Avenue

Mr. Chambers stated that last week he attended the budget meeting. He is concerned about the DPW's proposal of streets that need to be repaired. Due diligence needs to be done by this governing body. The cost per street, per effort needs to be done. A timeline also needs to be established.

#### Gary Masenior Recreation Director

Mr. Masenior stated he wants to make a correction to the report he presented to Council last meeting. In it he stated there was a trust balance of \$82,000; it has come to his attention that the trust fund balance is \$15,000. Councilman Higgins asked why the disparity. Manager Phelan explained that in 2009, \$145,000 was anticipated in revenue. Because it was anticipated revenue, the money had to be transferred from the trust fund to the current fund as anticipated revenue. Manager Phelan stated that Mr. Masenior did not see the cash side and he did not know we only had \$15,000 in trust. Manager Phelan stated that Council will need to raise the money via taxation to run the pool.

#### Rich Maguire – 234 West Washington Avenue

Mr. Maguire asked what the proposed tax increase is right now. Manager Phelan stated it is 1.54 rounded up, which is .30 cents. The cost is \$300 on a \$100,000 assessed home.

Motion to close the public hearing for the 2010 Introduced Municipal Budget was made by Cioni, seconded by Valentine.

At this time Council recessed for ten minutes. Council reconvened with everyone present.

Councilman Cioni and Councilman Boyle presented an analysis of Refuse Pick Up Options.

Councilman Cioni stated that he and Councilman Boyle put together a presentation that details the possible options for refuse collection for the 2011 fiscal year. The goal is to provide Council and taxpayers with options so that we can make educated decisions on future waste removal. Councilman Cioni stated that currently the Borough has a four year contract with Blue Diamond disposal that will cost approximately \$270,000 in 2010, \$259,000 in 2011, and \$265,000 in 2012. Bulk pickup was removed from the contract in 2011 and 2012.

Councilman Cioni presented four options. Option one is to keep everything the same and leave Blue Diamond as the contractor. Option two is to opt out of the current contract and have all affected go out for private pickup. Option three would be to opt out of the current contractor and provide refuse collection in house. Option four would be a shared service agreement with a contiguous municipality.

Councilman Cioni explained that option one will leave current service as is and the municipal budget will maintain the line item amounts each year for this service. The approximate cost is 11.83 cents on the tax rate.

Councilman Cioni stated that by going with option two the Borough would opt out of the contract all together, and affected persons will have to go to private garbage pickup. The costs from several solicited companies were between \$70.00 and \$107 per quarter. The savings is that the amount for waste pickup will no longer need to be raised through taxes resulting in an estimated amount of 11.83 cents per year off the municipal budget. The pros would be the municipality does not have to raise the money through taxation; resident has more control. Cons are the expense will be managed by the taxpayers themselves, potential for more than one carrier and abuse.

Councilman Cioni stated that option three is having the service done in house. The Borough will need to purchase a truck and hire two part time laborers. The pros will be there is no profit for an outside contractor and the Borough has more control. A new vehicle can last twenty years if properly maintained. Some of the cons are there are higher initial start up costs. The Borough would need a back up truck and training would be required. There would be vehicle maintenance costs and liability insurance increases.

Councilman Boyle presented option four by stating that there is a potential for a shared service agreement with several communities. The shared service must be equal or better

than the existing service and financial benefits must be demonstrated. There may be a concern over loss of control or a reduced level of responsiveness and the potential for increased costs at the end of an agreement.

Don Eller 44 W. Church

Mr. Eller stated that he does not want to see our employees involved in garbage collection. While he appreciates the informative presentation he would like to know what other municipalities that are similar in size spend on refuse collection. There are also many landlord/tenant issues that will come up with privatization.

Councilwoman Gleba asked what the cost is right now per household. Councilman Cioni stated it is between \$280 and \$350.

#### **COMMITTEE REPORTS:**

**DPW Garage:** Manager Phelan stated that there was a successful pre-construction meeting with the new general contractor and subcontractor. A new timeline has been put into place and progress is being made.

**Sewer Committee:** Councilman Higgins stated the sewer committee met on April 8 and is recommending that the Borough go with the first proposal from Stephanie Lewis. Proposal two should be done by the Manager and CFO; if they are not able to do proposal two then they recommend going with Ms. Lewis's number two proposal in 2011.

#### **Streets Committee:**

**Finance Committee:** Councilman Cioni stated the Frequently Asked Questions were answered by the CFO and Manager. These have been placed on the website.

**Shared Services Committee:** Councilman Boyle stated he is scheduled to meet with Glen Gardner the first week in May regarding refuse collection.

#### **Senior Services:**

Website Committee: - Councilman Cioni reported the comptrollers report is on the website.

**Park Committee** – Councilman Cioni stated there are no updates from the BID yet. There is a meeting scheduled at the end of April to discuss future options.

**Grant Committee: -** Councilwoman Gleba stated this committee will be meeting April 28 at 7:00 p.m. in the conference room.
