# **OLD BUSINESS:**

1. Open Space Referendum – Discussion

Kathy Haake from the Trust for Public Land spoke in support for the Open Space Referendum that the Borough is considering. She expressed hope that this would help acquire the Washington Station property also known as the Shabecong site. She noted it was a non-binding referendum in which Council will have the opportunity to hear from voters, and then decide if they want to access the tax. Ms. Haake explained that this tax

was a common tax and over half the municipalities in the state have this tax. If the referendum passes at 1.5, it will raise about \$56,000 a year which will cover a \$500,000 bond, a 5% bond for 30 years, with about \$10,000 annually left over to use towards maintenance or development for new or existent parks. It is about \$21 per average household per year. Funds will provide matching funds for the county grant, and it will enable the Borough to establish an Open Space Plan and submit a planning incentive grant to Green Acres. The Borough would then be able to receive up to 50% of all acquisitions costs for Open Space projects, as well as park development projects.

Attorney Kopen explained that should the Borough impose the tax, the money could be used for three purposes: acquisition of land, recreation and conservation, maintenance of land for recreation and conservation and payment of debt service on those. The statute also authorizes additional purposes should Council be interested in pursing development of any lands acquired, as well as preservation of historic properties. She noted that if in the future Council wanted to consider any of these additional purposes, they would have to put it out for referendum again. She explained that the Borough can only use the money for the specific purposes that are outlined in the referendum.

Councilman Boyle asked what a no vote would permit on the referendum. Council discussed including in the referendum that a no vote would be voting no for an Open Space Tax.

Attorney Kopen explained that for the next meeting she would have a resolution that would include the language for the ballot question, the interpretive statement and a resolution that sets forth the specific purposes that Council decides to put out there.

Councilman Higgins asked if the Borough could use the money to maintain the park that is down town.

Attorney Kopen explained that it could be, as long as it was included in the referendum.

Mayor McDonald entertained a motion to prepare the referendum as directed which includes language to maintain and develop Borough parks for recreation, and to include a no vote will impose a no open space tax. Motion made by Valentine, seconded by Higgins to prepare the referendum as directed.

Councilman Torres stated that he was not in favor of any new taxes whatsoever.

Councilman Jewell stated that he agreed with open space funding, but did not agree with a tax for Borough residents.

Councilman Higgins rescinded his second. Mayor McDonald seconded the motion to prepare the referendum as directed.

Manager Blanchard will write a letter to the Warren Hills Board of Education regarding the crosswalk on Belvedere and Carlton Avenue. She will also buy a temporary sign for that crosswalk and look into the rumble strips for Belvedere Ave. She will send a copy of the letter to the residents that spoke about their concern. Manager Blanchard will also make the bill list double sided.

#### **COUNCIL REMARKS:**

Councilman Boyle remarked that he reached out to the Borough of Hampton's Mayor Peter Winter. The Borough on Hampton would be interested in opening up discussions again about the garbage/solid waste collection. The Mayor of Hampton will bring this discussion to his council to get feedback from them. Councilman Boyle also commented that the Street Committee met July 13<sup>th</sup>, Councilman Jewell, Manager Blanchard and Lt. Ciseral were present. The meeting was about the overnight parking ordinance. Councilman Boyle read notes from the meeting. He stated that they asked the Lt. if there was any safety issues with overnight parking and there were none. During the meeting, the Manager stated if they were going to repeal the ordinance, to keep in mind there were some revenues generated per year approx. \$1500 in permits. There were a substantial amount of tickets written for overnight parking, \$9000 in fines. Correspondence from the County was also discussed at the meeting.

Councilman Jewell proposed a yearly parking permit for \$15-\$20 for overnight parking, with the exception of when it snows on emergency routes.

Manager Blanchard noted that anything the Council considers doing; they should not impose until January 1, 2013 because the Borough has already sold stickers for the 2012 year. She explained that she would like to go back to the county and ask for an extension until January 2013 to resolve the issue.

Councilman Jewell explained that his goal was to make this affordable to all.

Councilman Higgins encouraged everyone to visit Beethoven Ave, the project is finished.

Councilman Valentine expressed his disappointment with the results of the discussion of the referendum. He stated that Council is denying the right to voters in town to decide if they want the open space tax.

Councilman Torres stated that he was happy that the vote for the Open Space tax referendum did not go through, he believes that taxes are high enough. He also commented in regards to the overnight parking ordinance, that revenues could be gained the public parking lots in the downtown area.

Councilman Higgins asked if the cost for the ballot question was included in the retainer, or if it was a separate cost. Attorney Kopen replied that it was included in the retainer. Councilman Higgins noted that he was not in favor of any tax, but that the voters do have a right to determine if they would like to pay the extra tax. He explained that the question including the recreation is misleading towards the public.

Mayor McDonald wanted to congratulate Washington Celebrates America for a wonderful 4<sup>th</sup> of July celebration. He stated that Washington Borough has received a notice from the Warren County Mosquito Commission saying that they did find a deceased bird that tested positive for the West Nile virus in the Borough of Washington. The Warren County Mosquito Commission will do more testing, and if they feel it is necessary they will begin spraying.

Councilman Higgins motioned to allow the referendum question of specifically purchasing the 125 acres of land originally proposed by Washington HOPE, seconded by Valentine.
