## **COUNCIL APPEARANCES:**

Warren County Community College - Dr. William J. Austin, President

Dr. Austin introduced himself to Council and stated he was here to discuss the WCCC's 2011 Annual Report, which they are required by law to publish. In 2011, WCCC set a new record for graduating students and they continue to be among the fastest growing community colleges not only in New Jersey, but throughout the country. In September, the College successfully opened a satellite location in Phillipsburg. There are also plans for another satellite location in Hackettstown which will help to better serve all of Warren County. Dr. Austin also discussed their enrollment and retention

highlights. They have well over 2,000 students and their graduate numbers are up to 293. Dr. Austin thanked the Governing Body for their time this evening.

Recreation - Chairman, Victor Cioni and Director, Melissa Hommes

Chairman Cioni and Director Hommes appeared before Council to present the state of recreation for 2012. Chairman Cioni listed the highlights of recreation's many accomplishments. In 2012 recreation has completely renovated the snack bar to sell a larger selection of food to pool patrons. Recreation was able to completely restore the children's play sets and swings area with much needed play mulch as well as a much needed power wash. This cleaning will be done in the spring and fall each year. Recreation has been successful in creating new clinic programs for the children. In the winter, they created a Lil' Hoopsters Basketball Clinic for kids in grades K-2 at Taylor Street School which had a very positive response. Recreation also started a tennis clinic in conjunction with Warren Hills Tennis. This program was a huge success and they are looking to expand it for next year as well as looking into other new programs. Recreation also just held their First Annual 5K which was a huge success. They also started the process of state and national background checks on all coaches and assistant coaches of all Borough sponsored programs. Chairman Cioni provided a sports comparison and pool revenue breakdown of 2011 vs. 2012.

Councilwoman Gleba asked if recreation could provide the number of pool memberships from 2011 vs. 2012. She also requested the overall numbers for recreation in 2012. Melissa Hommes will provide that information to council.

# RESOLUTION AUTHORIZING THE MAYOR AND CLERK TO EXECUTE A SECOND AMENDMENT TO THE POWER PURCHASE AGREEMENT WITH WASHINGTON COMMUNITY SOLAR, LLC

**WHEREAS**, the Borough of Washington ("Borough") and Washington Community Solar, LLC ("WCS") entered into a Power Purchase Agreement ("PPA") dated December 30, 2011, for the purpose of providing solar energy to certain Borough facilities through solar facilities to be constructed by WCS on property in Washington Township adjacent to property owned by the Borough; and

**WHEREAS**, by the terms of the PPA, WCS had six months from the Effective Date of the PPA to obtain all required State and local regulatory permits, consents and approvals to enable it to construct its solar facilities; and

**WHEREAS**, WCS requested and the Borough granted it an approximate three month extension of time so that it had until September 30, 2012 to obtain the required permits and consents; and

**WHEREAS**, by letter dated September 27, 2012 WCS provided the Mayor and Council with an update of the status of the project as well as a request for a six-month extension of the time period set forth in Section 2 of the PPA giving WCS until March 31, 2013 to obtain all required approvals; and

**WHEREAS**, WCS also requested a corresponding six-month extension of the time period set forth in Section 3.3(a) of the PPA giving WCS until June 30, 2013 to begin providing electricity to the Borough; and

**WHEREAS**, WCS has offered to pave an approximate 800 foot section of the road on Borough property leading to the solar facilities; and

WHEREAS, the Mayor and Council have reviewed the request of WCS for the two extensions and have determined to accept the offer to pave the access road and grant the request of WCS for extensions to enable WCS to move forward with the project.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Washington, County of Warren, State of New Jersey, as follows:

A. The Mayor and Council consent to the amendment of Section 2 of the PPA to provide that Washington Community Solar, LLC shall have until March 31, 2013 to obtain all required State and local regulatory permits, consents and approvals, to design, permit, acquire, construct and install its solar facility.

- B. The Mayor and Council further consent to the amendment of Section 3.3(a) of the PPA to provide that WCS shall commence the delivery and sale of electricity to the Borough no later than June 30, 2013 which shall be the new Required Commencement Date under the PPA.
- C. The Mayor and Council accept the offer of WCS to pave an approximate 800 foot portion of the access road for the solar facility that is located on Borough property.
- D. The Mayor and Clerk are hereby authorized to sign an amendment to the PPA in a form acceptable to the Borough Attorney amending Sections 2 and 3.3(a) of the PPA and including a requirement for the paving of the access road all as set forth above.

# **COUNCIL REMARKS:**

Councilman Torres expressed his sympathy at the loss of former library employee Ms. Cindy Trimmer. The wake will be held at the Devoe Funeral Home.

Councilwoman Gleba said there were great things happening in October. Kudos to the Recreation Commission on their work with the 5K and congrats to the BID for a successful festival. Councilwoman Gleba also asked if there was something Council could do for Ms. Trimmer. Manager Blanchard mentioned a proclamation and the Mayor said possibly naming the children's section in her honor. Councilwoman Gleba also asked when the changes to the ordinance from the code book committee are needed by. Manager Blanchard said by January or February at the latest. Council discussed the professional proposals received. Council does need to re-advertise.

Motion made by Higgins to advertise on the Borough Website and the League of Municipalities for the following professionals: Municipal Attorney, Municipal Engineer, and Borough & Wastewater Engineer, seconded by Boyle and approved.

Councilman Valentine stated that the BID had a great festival and the Recreation Commission's 5K was great, and nice to see people downtown. He asked about the police presence at such an event like the 5K and asked Manager Blanchard to follow up. Manager Blanchard will check with the Recreation Commission as to what was discussed about police presence. Councilman Valentine also added that he noticed that a lot of trees downtown need to be trimmed. Manager Blanchard will discuss trimming the trees with the Shade Tree Commission.

Councilman Boyle stated that it was nice to see the vision that the Recreation Commission and the BID both have to improve and get people downtown. Councilman Jewell stated that the Fire Department will be holding their annual Halloween parade on October 28<sup>th</sup> at 2pm in front of the firehouse. He also said congratulations to Recreation on their 1<sup>st</sup> annual 5K and noted it is positive progress for the Borough. He also noted that the BID festival was great.

Councilman Higgins stated that he went to the DPW garage to see the 800 feet of blacktop. He also said that a gate should be considered at the bridge to prevent people from dropping off unacceptable items. Manager Blanchard already instructed John Burd to get estimates on gates. Councilman Higgins stated his displeasure in regards to the way the Jade Acquisition LLC. correspondence was presented at the last meeting. The in lieu of contribution should have been discussed with the entire Council. Councilman Higgins stated Mayor McDonald did not give Council that opportunity. Mayor McDonald disagreed, stating Council had plenty of time during the meeting to discuss this topic. Councilman Higgins also reminded everyone to be safe on Halloween.

Mayor McDonald expressed his sadness on the passing of Ms. Trimmer who worked for 19 years at the Borough Library. He also said he had a great time at the BID's festival and wished everyone a Happy Halloween.
