## **AUDIENCE:**

Mayor McDonald opened up the audience portion for remarks, petitions, statements, and testimony from guests.

Mr. John Montaverde – Washington Borough BID, Director

Mr. Montaverde reminded everyone that the Car Show and Green Festival is this Saturday, June 20th along with the Farmer's Festival. The Car Show and Green Festival has a rain date of Sunday June 21, 2015. Mr. Montaverde added that the BID is looking for volunteers to work in shifts directing traffic for the Sci-Fi Fantasy Day which

is scheduled for Saturday, July 11th.

Mr. Pete Quelly – 4 Cleveland Street

Mr. Quelly stated that on Cleveland Street between East Stewart Street and East Johnston Street there is no parking on both sides for as long as he can remember. Mr. Quelly added that somewhere along the way, the signs were removed and they need to be replaced so that the residents are aware that there is no parking on the street at any time especially during the winter so the street can be cleaned properly. Mr. Quelly also asked if hot tubs need to be fenced in according to the Borough's ordinance. Code Enforcement Officer Bescherer replied that hot tubs do not require a fence but it needs to have a proper cover.

Mr. Rich McGuire – 23 Green Street

Mr. McGuire stated that there is a problem on Green Street with the sidewalk and curb being cracked and broken after work was done to the water main. Councilman Higgins replied that Council gave permission for the Borough Manager to move forward with the curb repairs last year but unfortunately the weather did not cooperate and the work was not be completed. Councilman Higgins added that he was under the impression that the curb on Green Street was going to be repaired at the same time as the curb work on North Lincoln Avenue. Councilman Higgins suggested Council speak to Manager Blanchard and find out exactly what the contractor was instructed to do and asked that Borough Engineer Dawson Bloom takes a look at the situation.

Council Discussion:

Laurie Fay – 20 North Lincoln Avenue, David Lance – 177 Broad Street

Ms. Fay and Mr. Lance spoke on behalf of their mother, Ms. June Lance of 39 South Lincoln Avenue. Ms. Lance experienced a flood of raw sewage in her basement on Sunday January 18<sup>th</sup> due to a clogging issue two blocks away. Ms. Fay and Mr. Lance are seeking reimbursement on behalf of their mother for everything she lost in her basement. ServPro came out to the home to clean up the basement and everything within the basement had to be thrown out. Ms. Lance received a letter from the Borough's insurance company, Statewide Insurance Fund stating they have completed their investigation and since the Borough of Washington had no prior notice of the sewer main back up, the Borough cannot be held liable for the damage sustained. Attorney Parikh explained that the Borough of Washington is a public entity governed by the New Jersey Tort Claims Act under Title 59 of the New Jersey Statues which states that to establish liability a claimant must establish with indisputable proof that the public entity had notice of a dangerous condition and have sufficient time to have taken measures to protect against the condition. Mayor McDonald suggested the family speak to the New Jersey Department of Insurance to seek assistance and guidance in respect to this matter. Ms. Fay asked if the Borough could have Statewide Insurance Fund reverse their decision. Mayor McDonald replied that the Borough could ask Statewide to look into the claim again but without any new facts it is likely that Statewide would just reaffirm their decision. Councilman Higgins would like Manager Blanchard to resubmit Ms. Lance's claim and to contact Ms. Lance with the results.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF WASHINGTON, IN THE COUNTY OF WARREN AND STATE OF NEW JERSEY, AS FOLLOWS:

<u>Section 1</u>. The Borough of Washington, in the County of Warren, New Jersey, authorizes various capital improvements to be undertaken, including but not limited to various road improvements, acquisition of a mason dump truck, acquisition of

fire equipment and computer server for the Borough of Washington, to be funded from the sources specified in Section 2 of the Ordinance.

The amount of \$298,000 is hereby appropriated for the purposes Section 2.

Improvement Fund in the amount of \$298,000.

Section 3. In connection with the purpose and the amount authorized in Sections 1 and 2 hereof, the Borough determines the purpose described in Section 1

hereof is not a Current Expense and is an improvement which the Borough of

Washington may lawfully make as a general improvement.

Section 4. All ordinances or parts of ordinances which are inconsistent with

the terms of this Ordinance be and the same are hereby repealed to the extent of their

inconsistency.

This Ordinance shall take effect immediately upon final adoption and publication

according to law.
