Deputy Mayor Heinrich opened up the audience portion for remarks, petitions, statements, and testimony from guests.

Dave DeSanto – 66 Cemetery Hill Road

Mr. DeSanto stated that he is from Washington HOPE which is Homeowners Protecting the Environment and also protecting the value of the neighboring homes. Mr. DeSanto wanted to touch base with Council to see if there have been any subsequent meetings between the Borough of Washington and the Washington Cemetery regarding the unused 125 acres since the Technical Review Committee meeting with the Planning Board. Councilman Heinrich replied that Council is not aware of any further meetings that have taken place but Mayor McDonald or Manager Blanchard would be the most knowledgeable on the topic and will both be at the next Council Meeting on December 1st. Mr. DeSanto added that he was heavily involved during the time of the Washington Cemetery's last proposal in which the group worked toward preserving the property and received \$250,000 from Green Acres to assist with purchasing the property. DeSanto mentioned that unfortunately at that time the Council was not open to the idea of placing the question of the Open Space Fund on the ballot to ask the taxpayers interest. Mr. DeSanto added that at this point the Green Acres has had to withdraw their \$250,000 since the Washington HOPE was not previously successful in obtaining the rest of the funds so they would need to apply again. Councilwoman Noone replied that any time there is a proposal to get an item on the ballot, Council would need to know as far in advance as possible and encouraged Mr. DeSanto to get a formal presentation together.

Peter Quelly – 4 Cleveland Street

Mr. Quelly thanked Council for taking his concerns with chimineas and fire pits seriously and moving forward so there are limitations on how close to other homes they can be in

use. Mr. Quelly also reminded Council that Manager Blanchard had talked about possibly getting an extra "No Parking" sign in front of 6 Cleveland Street since there are numerous cars parked where they should not be. Deputy Mayor Heinrich noted that Manager Blanchard is not here tonight but he will remind her. Deputy Mayor Heinrich also added that the Ordinance for the chimineas and fire pits will be discussed at the December 1st Council Meeting.

Hearing no further comments from the audience a motion was made by Noone, seconded by Klimko to close the audience portion of the meeting.

Councilman Heinrich reminded Council that John Smith from Energy Market Exchange Company (EMEX) will be coming to do a presentation at the next Council Meeting. Councilman Heinrich added that Manager Blanchard provided Mr. Smith with the Borough's historical bills and EMEX will use that information to present a spreadsheet of potential cost savings. Councilman Heinrich stated that the Borough is trying a number of different options in order to save the Borough on energy costs. Councilman Heinrich wished everyone a Happy Thanksgiving next week.
