Council Discussion:

Councilman Higgins feels that Council should apply for the Safe Routes to School grant and would like to see sidewalks installed on North Lincoln Avenue. Municipal Engineer Bloom added that the requirements for the grant is that the location has to be within two miles of a school and the Borough would have to cover the portion of the costs that the grant does not. Municipal Engineer Bloom will get more information on the grant and report back to Council.

Councilman Higgins stated that he will forward the letter from the Spinks family in regards to North Wandling to the Streets Committee.

Councilwoman Klimko commented that the letter from Chief Cicerelle states that the Washington Township Police Department has received several complaints concerning enforcement of parking status throughout the Borough of Washington. Chief Cicerelle

would like to request that the DPW paint or repaint all the curbs yellow in appropriate areas as well as to install missing signage in order to aid the police officers with enforcement.

A motion was made by Higgins, seconded by Noone to forward Chief Cicerelle's letter to Manager Blanchard and get started on his request.

Deputy Mayor Heinrich opened up the audience portion for remarks, petitions, statements, and testimony from guests.

John Montaverde - Washington Borough Business Improvement District

Mr. Montaverde announced that the Active Shooter Protocol training session will take place on Thursday, May 12th at 11:45 am in the Washington Borough Fire Hall. The event is \$15 in advance, \$20 at the door and will be catered by the Lost Ladies Café. Mr. Montaverde added that Sci-Fi Fantasy Day is May 21st and will be a great, entertaining event.

Jay Arrington – Poetry in Motion

Mr. Arrington provided Council with an update on the Washington Theatre project including the fact that he will be purchasing the building instead of leasing it and plans on

closing within the next thirty to forty-five days.

Reverend Bauknight – Mt. Pisgah AME Church

Reverend Bauknight stated that one of the projects that the church is preparing for is installing a fence and there are items that belong to the Warren Hills Middle School where the properties meet and asked who she should contact. Council suggested that Reverend Bauknight contact Mrs. Patricia Hetrick, Principal and the Warren Hills Board of Education.

Hearing no further comments from the audience a motion was made by Conry, seconded by Higgins to close the audience portion of the meeting.

COUNCIL COMMITTEE REPORTS:

Streets Committee

Councilman Higgins stated that the Streets Committee would like to hold a public awareness for the construction of the downtown crosswalk on Wednesday, May 11th or Thursday, May 12th from 6:00 pm to 8:00 pm provided the fire hall is available. Municipal Engineer Bloom recommended that any notices or advertisements get out quickly.

Councilwoman Conry noted that the holes located at the intersection of Park Avenue and Route 31 are still there. Municipal Engineer Bloom noted that the holes are right at the corner of Park Avenue and may be the jurisdiction of the Department of Transportation and not part of the Environmental Protection Agency project but the Borough is able to patch the area.

A motion was made by Higgins, seconded by Klimko to fill in the holes near the crosswalk of Park Avenue and Route 31 within the next forty eight hours.

Sewer Committee

Municipal Engineer Bloom stated that the construction of the Gardeners Court sewer project should start tomorrow and that all of the residents have been notified. Municipal Engineer Bloom added that the project is to replace the eight inch main along Gardeners Court, installation of two manholes, and the tying in of the existing laterals. There will be no repair or replacement of laterals which will be the responsibility of the individual homeowners

RECAP:

Acting Clerk Kilduff stated that Municipal Engineer Bloom will obtain further details in regards to the Safe Routes to School grant including the matching amount and the timeframe. Manager Blanchard will correct page twenty of the April 05, 20 Meeting Minutes. Manager Blanchard will check the availability of the fire hall for May 11th or May 12th from 6:00 pm to 8:00 pm for a Streets Committee meeting advertised as a special meeting. Manager Blanchard will also check to make sure the residents of Gardeners Court were notified about the construction that is starting tomorrow and that the homeowners are responsible for their own laterals if so found.

COUNCIL REMARKS:

Councilman Higgins asked if the New Jersey American Water project on Jackson Avenue was going on to Church Street. Municipal Engineer Bloom replied that he will follow up but that he was not aware of any work being done on Church Street. Councilman Higgins added that he believes the residents in the area were not notified that the work was going to be done overnight. Municipal Engineer Bloom replied that the project was coordinated through the Department of Transportation and some aspects of the job were required to be completed at night. Councilman Higgins also added that there will be a Streets Committee meeting on May 9th at 10:00 am.

Councilwoman Klimko commented that there was a lot of heavy equipment stored in the area behind Taylor Street School. Municipal Engineer Bloom replied that the New Jersey American Water Company worked out an arrangement with the property owner to store the equipment there. Councilwoman Klimko added that there is a lot of activity during the night hours and feels the residents in that area were also not notified of the work being done. Municipal Engineer Bloom will look into if the project is in violation of the Borough's noise ordinance.

Councilman Thompson noted that there are a lot of holes in the road on Broad Street and it needs to be patched. Deputy Mayor Heinrich replied that he will remind Manager Blanchard to have Broad Street patched since it was brought up at the last meeting as well.

Councilwoman Noone thanked Mr. Bescherer for his work in contacting a property owner to have the property cleared of debris and abandoned vehicles.

Councilwoman Conry inquired about the status of the timeclocks since the Recreation Department will be opening the pool soon. Acting Clerk Kilduff will follow up with Manager Blanchard in regards to the timeclocks. Councilwoman Conry also wished all the mothers a Happy Mother's Day this coming Sunday.

Hearing no further business, a motion was made by Higgins, seconded by Noone to adjourn the meeting at 7:45 p.m.
