Resolution #114-206 Establishing a Special Period for Third Quarter Local Property Taxes

RESOLUTION # 114-2016 A RESOLUTION ESTABLISHING A SPECIAL PERIOD FOR THIRD QUARTER LOCAL PROPERTY TAXES IN THE BOROUGH OF WASHNGTON

WHEREAS, the printing and mailing of tax bills has been delayed beyond the N.J.S.A. 54:4-64 date of June 14th; and

WHEREAS, according to State Statute, taxes are due and payable February 1, May 1, August 1, and November 1 and these dates cannot be changed; and

WHEREAS, N.J.S.A. 54:4-67 allows the Borough Council to establish a grace period of 25 days from the date that tax bills are mailed; and

WHEREAS, the Borough of Washington has historically given its taxpayers a grace period of 10 days for each tax period.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Washington that the third quarter installment of current year taxes shall not be subject to interest until after August 29, 2016, the additional interest-free period authorized pursuant to R.S. 54:4-67. Any payment received on August 30, 2016 will be subject to interest charged back to the statutory date of August 1, 2016.

Resolution #115-2016 Hazard Mitigation Plan

Borough of Washington Resolution # 115-2016

WHEREAS the Borough of Washington, New Jersey, has experienced natural hazards that result in public safety hazards and damage to private and public property; WHEREAS the hazard mitigation planning process set forth by the State of New Jersey and the Federal Emergency Management Agency offers the opportunity to consider natural hazards and risks, and to identify mitigation actions to reduce future risk;

WHEREAS the New Jersey Office of Emergency Management is providing federal mitigation funds to support development of the mitigation plan;

WHEREAS a Hazard Mitigation Plan (HMP) has been developed by the Mitigation Steering and Planning Committees;

WHEREAS the Hazard Mitigation Plan includes a prioritized list of mitigation actions including activities that, over time, will help minimize and reduce safety threats and damage to private and public property, and

WHEREAS the draft plan was provided to each participating jurisdiction and was posted on the Warren County website so as to introduce the planning concept and to solicit questions and comments; and to present the HMP and request comments, as required by law.

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the Borough of Washington:

- 1. The Warren County Multi-Jurisdictional Hazard Mitigation Plan, as submitted to the New Jersey Office of Emergency Management and the Federal Emergency Management Agency on April 29, 2016 by the Warren County Department of Public Safety/Office of Emergency Management is hereby adopted as an official plan of the Borough of Washington; minor revisions recommended by the Federal Emergency Management Agency and/or the New Jersey Office of Emergency Management may be incorporated without further action.
- 2. The Borough of Washington departments identified in the HMP are hereby directed to pursue implementation of the recommended high priority activities that are assigned to their departments.
- 3. Any action proposed by the HMP shall be subject to and contingent upon budget approval, if required, which shall be at the discretion of the Mayor and Council, and this resolution shall not be interpreted so as to mandate any such appropriations.
- 4. The Warren County Deputy Public Safety Director and Deputy Office of Emergency Management Coordinator is designated to coordinate with other offices and shall periodically report on the activities, accomplishments, and progress, and shall prepare an annual progress report to be submitted to the Warren County Department of Public Safety/Office of Emergency Management. The status reports shall be submitted on a yearly basis by a predetermined date as agreed upon by all stakeholders.

WHEREAS, pursuant to <u>N.J.S.A.</u> 40:69A-94 permits the Borough to appoint an administrative officer of the Borough to the position of Manager in the event that the Manager is unable to perform his or her duties; and

WHEREAS, the Borough Council desires to appoint Jasmine Lim as the Borough's Interim Manager until such time as a permanent replacement for such positions can be found; and

WHEREAS, Ms. Lim understands and agrees that the appointment is interim and shall not have any of the rights set forth in <u>N.J.S.A.</u> 40:69A-93; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Washington, County of Warren, State of New Jersey, as follows:

1. Jasmine Lim is hereby appointed to the position of Interim Manager of the Borough of Washington until a permanent replacement can be found, such term not to exceed one hundred eighty four (184) days.

2. Jasmine Lim, as Interim Borough Manager, shall perform all of the duties of the Manager as set forth in <u>N.J.S.A.</u> 40:69A-95 and the Borough Code.

SEEKING COUNCIL CONFIRMATION OF BID RECEIVED BY THE TAX COLLECTOR ON THE ASSIGNMENT SALE OF BLOCK 94.01 LOT 07 CERTIFICATE #15-00042 MUNICIPAL HELD TAX SALE CERTIFICATE TO FWDSL & ASSOCIATES LP IN THE AMOUNT OF \$33,000.00

WHEREAS, N.J.S.A. 54:5-114 et. seq. (hereinafter the "Jones Act") allows the Tax Collector to sell certain municipal held tax sale certificates at a public sale to the highest bidder for an amount that may be lower than the amount due on each such certificate of sale; and

WHEREAS, the Tax Collector has received bids on the Block 94.01 Lot 7 certificate # 15-00042 at the Assignment Sale dated July 29, 2016 in the amount of \$33,000.00 from FWDSL and Associates LP; and

WHEREAS, pursuant to resolution #R 93-2016, adopted by the Borough Council of the Borough of Washington, the Tax Collector was authorized to hold a public sale of Block 94.01 Lot 7 Certificate 15-00042 Borough held liens; and

BE IT RESOLVED, that the Tax Collector is hereby charged with performing all notice requirements as per the Jones Act; and

WHEREAS, in accordance with the Jones Act the Assignment sale has been advertised in the Star Gazette on July 15th and July 22nd, 2016 as well as being posted in 5 public places in the Borough;

NOW THEREFORE BE IT RESOLVED, by the Borough Council of the Borough of Washington that the bid obtained on the Block 94.01 Lot 07 in the amount of \$33,000.00 from FWDSL & Associates LP that the Tax Collector sold pursuant to the Jones Act be confirmed; and

BE IT FURTHER RESOLVED, that a copy of this resolution along with its attachment be filed in the Office of the Borough Clerk.

Mayor McDonald reminded everyone National Night Out is tonight at Meadow Breeze Park and encouraged everyone to attend. The League Convention is coming up in Atlantic City. Mayor McDonald announced resident Emma Gray turns 100 years old today. A service was held at Mt. Pisgah Church where the Mayor presented her with a proclamation and where she also received a proclamation from the Church and letters from Senator Cory Booker and President Obama.
