<u>John Monteverde</u>, <u>BID Executive Director</u>, welcomed newly elect Councilman Norris. Flyers were handed out for the third annual Operation Jersey Care Support the Troops campaign.

Reverend Bauknight, thanked those who sent flowers, cards and support to her family.

<u>Debbie Spinks</u>, <u>State Street</u>, discussed the recently passed parking ordinance and the impact it has on her street for her and the elderly residents that live along State Street, which parking is now allowed only on one side.

<u>Michelle Norris</u>, <u>State Street</u>, expressed her concerns for the parking on State Street. Mrs. Norris expressed concerns her and the residents have with excessive speeding that occurs now that its only one-sided parking.

## RESOLUTION 2017-212 RESOLUTION APPROVING PAYMENT IN SETTLEMENT OF OPRA LITIGATION

**WHEREAS**, Jesse Wolosky filed an action against the Borough of Washington (the "Borough") before the Government Records Council ("GRC") alleging certain violations of the Open Public Records Act ("OPRA") relating to a certain OPRA request he filed on November 10, 2015 with the Borough's former Clerk / Manager; and

**WHEREAS**, pursuant to his November 10, 2015 OPRA request, Mr. Wolosky requested the following documents:

- Actual existing official year-end payroll records for 2012, 2013 and 2014 or the last pay stub for the custodian for the same years.
- Detailed vendor history activity report by vendor name for the custodian from January 1, 2008 through the present showing her personal reimbursements.
- Records of the custodian's continuing education and courses for her certification renewal for 2012, 2013, 2014 and 2015; and

**WHEREAS**, Mr. Wolosky alleged that the Borough violated OPRA by (1) failing to respond within the required seven day time limit; (2) the Borough improperly redacted certain documents; (3) the Borough failed to provide the vendor reports; and (4) the Borough failed to provide the continuing education records; and

**WHEREAS**, after consideration of submissions by Mr. Wolosky's counsel and the Borough's counsel, the GRC held that the Borough had violated OPRA; and

**WHEREAS**, the GRC determined that Mr. Wolosky was only entitled to attorney's fees with regard to the provision of the vendor history reports; and

**WHEREAS**, Mr. Wolosky's counsel has stated that she intends to file a motion for reconsideration of the GRC's decision if the parties cannot amicably resolve the issue of attorney's fees; and

WHEREAS, the Borough desires to resolve this matter; and

**WHEREAS**, counsel for Mr. Wolosky has agreed to accept the amount of \$5,500 in full settlement of this matter.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Washington, County of Warren, State of New Jersey, as follows:

- 1. The Borough Attorney is hereby authorized to settle the above-referenced matter for the amount of \$5,500, subject to the Borough Attorney's review of a Settlement Agreement.
- 2. The Borough Attorney, Mayor, Clerk, and Chief Financial Officer are authorized to take any steps necessary to implement this Resolution.

Motion made by Noone and Heinrich to approve Resolution 2017-213.
