### BOROUGH OF WASHINGTON, WARREN COUNTY, NEW JERSEY WASHINGTON BOROUGH COUNCIL MINUTES -December 19, 2017

The Business Meeting of the Borough Council of Washington, Warren County, New Jersey was held in the Council Chambers of Borough Hall at 7:00 P.M.

Roll Call: Heinrich, Higgins, Klimko, Noone, Norris, Thompson and Valle.

Also, Present: Matthew Hall, Manager Laurie A. Barton Borough Clerk Leslie Parikh, Attorney

Mayor Higgins led everyone in the flag salute.

Mayor Higgins read the following Statement into the Record:

"The requirements of the 'Open Public Meetings Law, 1975, Chapter 231' have been satisfied in that adequate notice of this meeting has been published in the Star Gazette and posted on the Bulletin Board of Borough Hall stating the time, place and purpose of the meeting as required by law."

#### **Audience**

<u>Jeanine Gleba, Library Board of Trustee</u>, discussed budget concerns for the library and explained the past history of the Borough and cuts to budgets. A graph was distributed on where the library was and where it is today financially.

Rev. Bauknight, Library Board President, stated the library is looking into receiving additional funding. There are issues with staffing with two-part timers, where if one is out sick the library either closes early or closes all together. The board is putting into budget to hire two full time additional people.

Rev. Bauknight stated that all members of the board have to obtain mandatory training, including Mayor and Deputy Mayor. The board also submitted a list of items they need from the capital improvement budget.

<u>John Monteverde</u>, <u>BID</u>, thanked everyone for coming out to the hometown holiday. Mr. Monteverde thanked the police and fire department in their involvement. Two new restaurants opened up in town. The laundry-mat is now up and running since the fire.

<u>John Valentine</u>, <u>Washington Ave.-Library Board Trustee</u>, stated the importance of operating and keeping the library in the borough.

Rob Colentrelle, LMR Disposal, read a prepared statement in regards to his recent bid for garbage disposal, in which he indicated he may appeal the judges' decision (awarding bid to Blue Diamond).

<u>Chris Vitalis(sp), Chairman, Zoning Board</u>, discussed the merger the boards (Zoning & Planning) would like to accomplish citing the difficulties in recruiting members for both boards.

Mayor Higgins at this time explained circumstances surrounding Councilman Norris describing what he and others received in the mail recently. Mayor Higgins announced he is removing Councilman Norris from the streets committee.

Mayor Higgins stated he personally felt it was in the best interest of the Borough in light of Mr. Norris's criminal history to resign and asked for Mr. Norris's resignation, in which Mr. Norris declined to resign.

Mayor Higgins asked for a motion of no confidence.

Motion made by Heinrich and seconded by Noone to a vote of no confidence towards Councilman Norris.

ROLL CALL: Heinrich, Higgins, Noone, and Thompson. Ayes: 4, Nays: 1 (Klimko, Norris), Abstain: 1(Valle) Motion carried.

Mayor Higgins called a five-minute break.

Motion made by Heinrich and seconded by Noone to break from regular session for five minutes. All were in favor.

Meeting resumed with Mayor Higgins again asking for Mr. Norris's resignation from council for reasons stated previously. Again, Councilman Norris declined to resign.

#### **Council Remarks**

Councilman Thompson wished everyone to enjoy the holiday and be safe.

Councilwoman Klimko wished everyone a Merry Christmas and Happy New Year.

Councilman Norris wished everyone a Merry Christmas.

Councilwoman Valle wished everyone a Merry Christmas.

Councilwoman Noone congratulated the new businesses in town and wished everybody a happy holiday.

Councilman Heinrich thanked the library for coming in tonight and concurred with statements on how important the library is. Councilman Heinrich wished everyone a health happy holiday and new year.

Mayor Higgins reported on the Washington Celebrates America committee receiving extra fireworks for their celebration next year, which will cost an additional \$3,000.00 It was the consensus of Council to add an additional \$3,000.00 to the budget for the 4<sup>th</sup> of July Fireworks celebration.

Mayor Higgins wished everyone a Merry Christmas and happy healthy new year. Mayor Higgins also thanked Mr. Monteverde with the Christmas tree lighting event and thanked the fire and police departments in their involvement.

# RESOLUTION AWARDING THE CONTRACT FOR SOLID WASTE, YARD WASTE AND RECYCLABLE MATERIALS AND COLLECTION AND DISPOSAL SERVICES TO BLUE DIAMOND DISPOSAL, INC.

WHEREAS, the Borough of Washington (the "Borough") issued bid specifications for a contract for solid waste, yard waste, and recyclable materials collection and disposal services; and WHEREAS, at the bid opening on August 31, 2017, the Borough received two responses from LMR Disposal Services, LLC ("LMR") and Blue Diamond Disposal, Inc., as follows:

**WHEREAS**, by resolution dated October 3, 2017, the Borough awarded the contract to LMR;

**WHEREAS,** Blue Diamond appealed the Borough's decision by Order to Show Cause (<u>Blue Diamond Disposal, Inc. v. Borough of Washington, et al.</u>, Docket No. WRN-L-289-17);

**WHEREAS,** the Borough, Blue Diamond, and LMR submitted briefs to the Court and appeared before the Honorable John H. Pursel, J.S.C. on December 13, 2017 for a hearing on the matter;

**WHEREAS,** after such hearing Judge Pursel issued an oral opinion ordering that the contract be awarded to Blue Diamond;

**WHEREAS**, the Borough's Chief Financial Officer has determined that Blue Diamond's base bid does not "substantially [exceed] the cost estimates for the goods or services" pursuant to N.J.S.A. 40A:11-13.2;

**WHEREAS**, the Borough's Chief Financial Officer has determined that Blue Diamond's bid for bulk household waste pick-up (Options #1 and #2) "substantially [exceed] the cost estimates for the goods or services" pursuant to N.J.S.A. 40A:11-13.2; and

**WHEREAS,** the Borough has determined that it is in its best interested to reject the bids for Options #1 and #2 and advertise for bids for bulk waste pick up.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Washington, County of Warren, State of New Jersey, as follows:

- 1. In compliance with the Court's order issued in <u>Blue Diamond Disposal</u>, <u>Inc. v. Borough of Washington</u>, et al., Docket No. WRN-L-289-17, the bid for a contract for solid waste, yard waste, and recyclable materials collection and disposal services is awarded to Blue Diamond Disposal, Inc. with regard to the Base Bid.
- 2. Subject to the approval by the Borough Attorney as to form, the Mayor and the Borough Clerk are hereby authorized and directed to execute a contract for the same.
- 3. Pursuant to N.J.S.A. 40A:11-13.2 Blue Diamond's bid for bulk household waste pick up is rejected and the Borough Clerk and Manager are authorized to take all steps to advertise and re-bid a contract for such services.

Chief Cicerelle was asked by Mayor Higgins to explain the circumstances under which Mr. Norris applied for a purchaser permit and was ultimately denied.

Chief Cicerelle stated based on what occurred regarding a request from Mr. Norris inquiring about GPS on police vehicles and the denial of a firearm permit, which he stressed he cannot go into detail, stated that his concerns were a potential conflict concerning voting issues with the police. Chief Cicerelle referred his concerns to the Prosecutors office for guidance on the situation.

Attorney Parikh stated she will look more into cases concerning abstentions where there is a potential conflict.

#### **ADJOURNMENT**

Hearing no further business, a motion was made by Klimko seconded by Valle to adjourn the meeting at 9:50 pm.
