COUNCIL APPEARANCE

Edward France, Vanatta Street, stated his concerns with the way he feels when he comes to borough hall. Mr. France also discussed his recent violations he received regarding his property. It was explained to Mr. France by Mayor Higgins the process in which he can take to make a complaint regarding a borough employee.

Mr. France asked in the future to consider giving warnings instead of a violation ticket.

Attorney Parikh confirmed Mayor Higgins advice on issues with an employee and stated to Mr. France that he is free to address council, but they are instructed not to respond to employee matters. <u>Dale Parichuk, Myrtle Ave.</u>, addressed council on the hiring of the current zoning and fire subcode official and stated that the disabled veteran who had applied should have been given the preference and been offered the job. Mr. Parichuk went on to state he is filing a declaratory judgment.

<u>Lieutenant James Teter, Washington Township Police,</u> stated he stands as a tax payer and on behalf of the police department and stated he agreed that the ordinance should be discretionary and with the repetitive code enforcement, it has made a huge increase of quality of life. Lt. Teter added that the police department 100% agrees with Mr. Lopez, making people responsible for their properties. Lt. Teter also pointed to Mr. Parichuk that when a snow emergency is announced, is when it becomes in affect. It is not up to the residents to decide its clear, it's when the emergency is lifted. Lt. Teter added that on behalf of the whole police department, Matt Lopez is doing a great job.

<u>Dave Desanto, Cemetery Hill,</u> inquired about any updates regarding the 120 acres of undeveloped property in the borough.

<u>Ethel Conry, Youmans Ave.</u>, commented on the good job Matt Lopez has been doing for the borough. Ms. Conry also thanked the police, mayor and everyone on council for doing a good job.

Ms. Conry inquired about the bushes along Rail Road Ave and asked if they will be cut. Ms. Conry also thanked Mayor David Higgins on his contribution to the NAACP scholarship fund. <u>Jerry Cucci (sp), Washington Square,</u> discussed his property he owns at 33 East Washington Ave and stated he is asking for an extension on his permit he has with the State DOT, for work that is being done to the property.

ORDINANCE 2018-14 BOROUGH OF WASHINGTON AN ORDINANCE PROVIDING FUNDING FOR PURCHASE OF FURNITURE AND COMPUTER EQUIPMENT FOR THE BOROUGH OF WASHINGTON LIBRARY AND APPROPRIATING \$11,459.98 FOR SUCH PURPOSE.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF WASHINGTON, IN THE COUNTY OF WARREN AND STATE OF NEW JERSEY, AS FOLLOWS:

<u>Section 1</u>. The Borough of Washington, in the County of Warren, New Jersey, authorizes purchase of furniture and computer equipment for the library capital improvement to be undertaken, to be funded from the sources specified in Section 2 of the Ordinance.

<u>Section 2</u>. The amount of \$11,459.98 is hereby appropriated for the purposes stated in Section 1 of the Ordinance and which amount was funded from the General Capital Improvement Fund in the amount of \$11,459.98.

<u>Section 3.</u> In connection with the purpose and the amount authorized in Sections 1 and 2 hereof, the Borough determines the purpose described in Section 1 hereof is not a Current

Expense and is an improvement which the Borough of Washington may lawfully make as a general improvement.

<u>Section 4</u>. All ordinances or parts of ordinances which are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.

<u>Section 5.</u> The capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the Borough Clerk and are available for public inspection.

<u>Section 6</u>. This Ordinance shall take effect immediately upon due passage and publication according to law.

RESOLUTION OPPOSING NJDOT ROUTE 80 ROCK MITIGATION PROJECT THROUGH THE DELAWARE WATER GAP IN HARDWICK AND KNOWLTON TOWNSHIPS

WHEREAS, the New Jersey Department of Transportation (NJDOT) intends to build a series of high industrial fences and a 60-foot-high concrete pyramid called a "rockfall berm" along Route 80 through the Delaware Water Gap; and

WHEREAS, the proposed Route 80 Rockfall Migration will be built on lands located in Hardwick and Knowlton Townships and the Delaware National Water Gap Park; and

WHEREAS, stakeholders Hardwick Township and Knowlton Township have formally opposed the project, and have not given their permission for this project within their boundaries; and

WHEREAS, construction of the Route 80 fence is slated to begin in 2020 and is expected to last two years, and

WHEREAS, in 2012 this project's cost was estimated at \$6 million but has now ballooned to \$59.1 million according to the current Capital Transportation Plan on the NJDOT website; and

WHEREAS, the \$59.1 million price tag is substantially more than comparable NJDOT rock mitigation projects in Andover Township, Denville, and Bethlehem Township New Jersey, which are listed on the NJDOT website as costing \$4.65 million, \$3.25 million, and \$8 million; and

WHEREAS, the NJDOT's Concept Development Report acknowledges that "NJDOT" provided limited rockfall event data, and the actual frequency of rock activity is unknown for this project; and

WHEREAS, there are no documented rockfall events nor any recollections of significant rockfall events over the last ten years within Area "D" portion of the project where the concrete pyramid is to be placed; and

WHEREAS, there are 70 to 80 motor vehicle accidents on Route 80 in this section of Route 80 annually due to speed and poor road conditions yet this project involves no road improvements; and

WHEREAS, two years of construction on Route 80 will have significant negative impact on residents for New Jersey and Pennsylvania and on emergency personnel's ability to get to nearby hospitals; and

WHEREAS, the Delaware Water Gap is a nationally prominent scenic wonder and a gateway to the one of the most widely used National parks in the nation; and

WHEREAS, the proposed project will impact the viewshed of Point of Gap Overlook, near the Appalachian Trail, which has an entrance at the Delaware Water Gap Park; and

WHEREAS, the income generated by tourism to the Delaware Water Gap and the scenic value of Northwest New Jersey will likely be negatively impacted by the proposed fence; and

WHEREAS, the American Society of Civil Engineers gave the state of New Jersey a grade of D-plus in 2017 for the poor state of its roads and bridges; and

WHEREAS, the \$59.1 millions of dollars appropriated for this non-essential rock mitigation project would be better directed to repairing the roads and bridges in Northwest New Jersey.

NOW, THEREFORE, BE IT RESOLVED on this 7th day of June 2018, that the Borough of Washington opposes the current NJDOT Route 80 Rockfall Mitigation Project and requests the assistance of the following elected Representatives in halting the current NJDOT project:
