Ms. Gale stated that the next step is for the Land Use Board to adopt their plan and Council will have a chance to review prior to introduction and adoption of ordinances that are recommended.

Ms. Gale also stated from speaking with Attorney St. Angelo, to expedite things more efficiently, it is highly recommended that a subcommittee be created to discuss and make recommendations and bring back a final draft to a council meeting. Ms. Saglioni's intent is to save the program from being eliminated.
