**WHEREAS**, the Shabbecong Creek watershed encompasses nearly 100% of the Borough land mass and the protection of this watershed is critical to the Borough's environmental integrity; and

**WHEREAS**, the Taylor Street School located with the Shabbecong Creek watershed is almost completely covered with impervious surfaces; and

**WHEREAS**, a rain garden demonstration project would provide an example of how the Borough can improve watershed protection for Shabbecong Creek; and

**WHEREAS**, a rain garden would provide much needed green space for the Taylor Street School and encourage educational opportunities for students; and

**WHEREAS**, a rain garden would improve the neighborhood's aesthetics and could inspire others to be more aware of the natural environment; and

**NOW THEREFORE IT BE RESOLVED** by the Mayor and Council of the Borough of Washington, County of Warren, State of New Jersey; To support the Washington Borough Green Team initiative to work with the Taylor Street School officials and the non-profit organization, North Jersey Resource Conservation and Development, in constructing a rain garden demonstration project to serve as an example of how to improve the Shabbecong Creek watershed's water quality and reduce flooding; provide a green space for the Taylor Street School; encourage educational opportunities at the School and for others; and enhance the ambiance of the local neighborhood.

# COUNCIL REMARKS

Councilwoman Noone spoke of the grant application to have a rain garden at Taylor Street playground.

Councilwoman Duchemin thanked the DPW for doing a great job in the recent ice storm and expressed her excitement for the rain garden.

Councilwoman Valle stated it will be a cute touch for the Taylor Street playground (rain garden).

Councilman Norris thanked the police for their excellent job and the DPW for their work during the storm keeping the roads safe.

Councilwoman Conry thanked the police and DPW for their wonderful job. A senior committee meeting will be held this Friday at 7:00 pm.

Mayor Higgins stated that the BID dinner went well. A new representative from the League (NJLM) is Colleen Marr (sp). Mayor Higgins added that she can assist with anything that involves local government.

Lieutenant Kaufman gave the statistics of a recent inquiry into how many times Narcan was administered. 170 Narcan totals were administered in the county. 21 in the Township. There were three overdose deaths that occurred each in the Township and the Borough.

Mayor Higgins continued on with his comments adding that the police take a beating with opinions from the public.

Mayor Higgins reminded council of the retreat that is this Saturday at Gebhardt and Kiefer's offices.

Councilman Norris gave a summary of the committee meeting that was held with Councilwoman Valle regarding the housing authority ordinance in which Matt Lopez was also in attendance to assist.

Matthew Lopez gave a brief breakdown of intent and stated that it is similar to what Phillipsburg and Morristown have adopted in regards to a having a Housing Authority.
