ORDINANCE 2019-17

AN ORDINANCE TO MANDATE DIRECT DEPOSIT FOR COMPENSATION FOR MUNICIPAL EMPLOYEES OF THE BOROUGH OF WASHINGTON EFFECTIVE SEPTEMBER 1, 2019 PURSUANT TO N.J.S.A. 52:14-15f

WHEREAS, N.J.S.A. 52:14-15f authorizes local governments to mandate direct deposit for compensation for certain governmental employees effective July 1, 2014; and

WHEREAS, N.T.S.A. 52:14-15f permits governing bodies to grant exemptions to the direct deposit requirements on such terms and conditions as they deem necessary; and

NOW, THEREFORE BE IT ORDAINED, by the Mayor and Council of the Borough of Washington, in the County of Warren, as follows:

SECTION 1.

- A. All full-time employees, part-time employees, and elected public officials who receive compensation from the Borough of Washington are mandated to have direct deposit of their compensation as of September 1, 2019 in accordance with NJ.S.A. 52:14-15f.
- B. Municipal employees may request an exemption from the direct deposit requirements of this Ordinance by written request to the Municipal Manager of the Borough of Washington. A decision on such request will be considered by the Borough Manager within seven (7) days of receipt. The Borough Manager may grant an exemption from the requirements of this Ordinance for good cause shown on such terms and conditions as the Borough Manager may deem necessary.

SECTION 2. If any Section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the Section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deeded valid and effective.

SECTION 3. All ordinances or parts of ordinances inconsistent with or in conflict with this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. This ordinance shall take effect upon adoption, passage and publication according to law. The Direct Deposit mandate shall be effective September 1, 2019.

- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
 - 4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated,
 - b. Items of appropriation are properly set forth
 - c. In itemization, form, arrangement and content, the budget will

permit the exercise of the comptroller function within the municipality.

- 5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
 - 6. That all other applicable statutory requirements have been fulfilled.
