As long as its not raining we will get a minimum of 10,000 in town just that one day. This is a great business maker for businesses. Vendors open at 10am music goes until 10pm.

# Josephine Noone- National Wildlife Federation Community Wildlife Habitat Program

Mrs. Noone represents the Green Team, and stated that she has been trying to put an advertisement in the Messenger. One of the members is Michael Franks-has been doing trail preservation, trying to build a trail at end of Nunn Avenue. On September 23<sup>rd</sup> will be leading some trail development and clearing the trail. Oct 21<sup>s</sup> at 10 am will lead a hike so people can see where trail is. Thanked Council for the budget for the Green Team.

# AN ORDINANCE AUTHORIZING AS A GENERAL IMPROVEMENT THE TAX MAPS FOR THE BOROUGH OF WASHINGTON AND APPROPRIATING \$20,000.00 THEREFORE FROM THE "CAPITAL FUND BALANCE" OF SAID BOROUGH

BE IT ORDAINED by the Borough Council of the Borough of Washington in Warren County,

New Jersey as follows:

<u>Section 1</u>. The Borough of Washington in Warren County (hereinafter referred to as

"Municipality") is hereby authorized the following Capital Improvements for the Borough of Washington:

1. Updates to the Borough of Washington Tax Maps.

<u>Section 2</u>. The work and acquisitions, authorized by Section 1 of this Ordinance shall be undertaken as

a general improvement, the entire cost of which shall be contributed and borne by the municipality as a general

expense, and no part of said cost shall be specially assessed against any property. The estimated cost noted

of such project shall not exceed \$20,000.00 unless this Ordinance is amended.

<u>Section 3</u>. It is hereby determined and stated that the undertaking of the aforesaid projects (hereinafter

referred to as "purpose") is not a current expense of the municipality; and that the total estimated cost of said

purpose is \$20,000.00, the estimated cost for the projects having been noted in Section 1 above.

Section 4. The sum of \$20,000.00 is hereby appropriated for said purpose from the "Capital

Fund Balance" of the municipality for said purpose as required by law and now available therefore under

budget or budgets of the municipality previously adopted.

 $\underline{\text{Section 5}}.$  The Capital budget of the municipality is hereby amended to conform with the provisions of

this Ordinance to the extent of any inconsistency herewith.

<u>Section 6</u>. This Ordinance shall take effect upon its passage and publication as provided by law.

# BE IT RESOLVED BY THE MAYOR AND COMMON COUNCIL OF THE BOROUGH OF WASHINGTON, IN THE COUNTY OF WARREN, NEW JERSEY, AS FOLLOWS:

Pursuant to a bond ordinance of the Borough of Washington, in the County of Warren (the "Borough"), entitled: "Bond ordinance providing for the improvement of various roads in and by the Borough of Washington, in the County of Warren, New Jersey, appropriating \$1,210,000 therefor and authorizing the issuance of \$1,031,000 bonds or notes of the Borough for financing such appropriation", finally adopted on September 5, 2023 (#2019-18, formerly #2018-10), bond anticipation notes of the Borough in a principal amount not exceeding \$921,736.84 shall be issued for the purpose of temporarily financing the improvement or purpose described in Section 3 of said bond ordinance, including (to any extent necessary) the renewal of any bond anticipation notes heretofore issued therefor.

Pursuant to a bond ordinance of the Borough, entitled: "Bond ordinance providing for the acquisition of a new fire pumper truck by the Borough of Washington, in the County of Warren, New Jersey, appropriating \$500,000 therefor and authorizing the issuance of \$465,000 bonds or notes of the Borough for financing such appropriation", finally adopted on September 5, 2023 (#2019-19, formerly #2018-11), bond anticipation notes of the Borough in a principal amount not exceeding \$415,526 shall be issued for the purpose of temporarily financing the improvement or purpose described in Section 3 of said bond ordinance, including (to any extent necessary) the renewal of any bond anticipation notes heretofore issued therefor.

Pursuant to a bond ordinance of the Borough, entitled: "Bond ordinance providing for the acquisition of a new fire command vehicle by the Borough of Washington, in the County of Warren, New Jersey, appropriating \$38,000 therefor and authorizing the issuance of \$16,000

bonds or notes of the Borough for financing such appropriation", finally adopted on September 5, 2023 (#2019-06), bond anticipation notes of the Borough in a principal amount not exceeding \$12,422.16 shall be issued for the purpose of temporarily financing the improvement or purpose described in Section 3 of said bond ordinance, including (to any extent necessary) the renewal of any bond anticipation notes heretofore issued therefor.

Pursuant to a bond ordinance of the Borough, entitled: "Bond ordinance providing for the acquisition of a new street sweeper by the Borough of Washington, in the County of Warren, New Jersey, appropriating \$250,000 therefor and authorizing the issuance of \$237,500 bonds or notes of the Borough for financing such appropriation", finally adopted on June 18, 2019 (#2019-14), bond anticipation notes of the Borough in a principal amount not exceeding \$229,310 shall be issued for the purpose of temporarily financing the improvement or purpose described in Section 3 of said bond ordinance, including (to any extent necessary) the renewal of any bond anticipation notes heretofore issued therefor.

Pursuant to a bond ordinance of the Borough, entitled: "Bond ordinance providing for the acquisition of new dump trucks by the Borough of Washington, in the County of Warren, New Jersey, appropriating \$1,300,000 therefor and authorizing the issuance of \$1,238,000 bonds or notes of the Borough for financing such appropriation", finally adopted on October 1, 2019 (#2019-26), bond anticipation notes of the Borough in a principal amount not exceeding \$1,238,000 shall be issued for the purpose of temporarily financing the improvement or purpose described in Section 3 of said bond ordinance, including (to any extent necessary) the renewal of any bond anticipation notes heretofore issued therefor.

All bond anticipation notes (the "notes") issued hereunder shall mature at such times as may be determined by the treasurer, the chief financial officer or the acting chief financial

officer of the Borough (the "Chief Financial Officer"), provided that no note shall mature later than one year from its date. The notes shall bear interest at such rate or rates and be in such form as may be determined by the Chief Financial Officer and shall be signed and sealed by officials and officers of the Borough in any manner permitted by N.J.S.A. §40A:2-25. The Chief Financial Officer shall determine all matters in connection with the notes issued hereunder, and the Chief Financial Officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of N.J.S.A. §40A:2-8. The Chief Financial Officer is hereby authorized to sell part or all of the notes at not less than par from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price. The Chief Financial Officer is directed to report in writing to the governing body of the Borough at the meeting next succeeding the date when any sale or delivery of the notes hereunder is made. Such report must include the principal amount, interest rate and maturities of the notes sold, the price obtained and the name of the purchaser.

Any note issued pursuant to this resolution shall be a general obligation of the Borough, and the Borough's faith and credit are hereby pledged to the punctual payment of the principal of and interest on the notes and, unless otherwise paid or payment provided for, an amount sufficient for such payment shall be inserted in the budget and a tax sufficient to provide for the payment thereof shall be levied and collected.

The Chief Financial Officer is hereby authorized and directed to do all other matters necessary, useful, convenient or desirable to accomplish the delivery of the notes to the purchasers thereof as promptly as possible, including (i) the preparation, execution and dissemination of a Preliminary Official Statement and Final Official Statement with respect to the notes, (ii)

preparation, distribution and publication, if necessary, of a Notice of Sale with respect to the notes,

(iii) execution of a Continuing Disclosure Undertaking, with respect to the notes in accordance

with Rule 15c2-12 promulgated by the Securities and Exchange Commission and (iv) execution

of an arbitrage and use of proceeds certificate certifying that, among other things, the Borough, to

the extent it is empowered and allowed under applicable law, will do and perform all acts and

things necessary or desirable to assure that interest paid on the notes is not included in gross income

under Section 103 of the Internal Revenue Code of 1986, as amended.

All action heretofore taken by Borough officials and professionals with regard to

the sale and award of the notes is hereby ratified, confirmed, adopted and approved.

# ORDER FOR THE DEMOLITION OF THE GARAGE AT BLOCK 20.03 LOT 2, 181-183 BELVIDERE AVENUE

WHEREAS, on August 29, 2023, the Mayor and all council members held a public hearing on the fitness and habitability of a garage located on the property with a street address of 181-183 Belvidere Avenue and on the Borough tax records as Block 20.03 Lot 2 with the record owner of the property being Maria V. Malaret:

**WHEREAS,** testimony, under oath, was taken from Joseph Rossi, the Borough's Construction Code official, who testified to the following facts:

- 1. On or about July 27, 2021, Mr. Rossi inspected the garage determining that it was unfit for habitation and issued a Notice of Unsafe Structure giving the owner ninety (90) days to repair the garage because it was "falling apart". The ninety (90) day period was ultimately extended to March 1, 2022;
- 2. On March 1, 2022, Mr. Rossi issued a Notice from Construction issuing a Summons to appear in Municipal Court on March 22, 2022 because the owner did not perform any work to repair the garage. On March 22, 2022, the Court fined the property owner and ordered the owner to repair the garage within ninety (90) days;
- 3. During his inspection on July 27, 2021 Mr. Rossi took photographs of the garage. The photographs depict a garage with no roof, missing windows and other defects. Mr. Rossi testified that the garage was in "relatively good shape" needing a roof, windows and some other work;
- 4. Mr. Rossi testified that he inspected the garage again in July of 2023 and took photos which depicted the second floor of the garage "bowing out" of the side wall of the garage and windows "blown out". Mr. Rossi testified that the "bowing out" of the side of the garage and the "blown out" windows indicated that the framing of the building is starting to implode with an imminent danger of collapse;
- 5. During an inspection of the garage on August 28, 2023, photos taken by Mr. Rossi showed that the second floor of the garage had collapsed and second floor siding was no longer attached to the structure, the rafters were gone, and the main beam falling down completely;
- 6. Mr. Rossi testified that in his opinion, the garage would collapse within six (6) months or could collapse tomorrow;
- 7. Mr. Rossi testified that the garage was a danger to life because, despite police installing saw horses, people, including children, were often in close proximity to the garage and that if it collapsed, it could land on anyone near it causing injury or even death. Additionally, Mr. Rossi stated there was concern that curious kids would enter the unstable garage and cause it collapse while inside;
- 8. Mr. Rossi stated that if the garage collapsed, due to its close proximity to the adjoining property owner's garage, the collapse would cause damage to the neighbor's garage;

9. Mr. Rossi recommended that the Council issue an Order requiring the owner to either demolish the garage or file plans, prepared by a structural engineer, for the repair of the garage and that the demolition or repairs be completed within ninety (90) days. Further, Mr. Rossi recommended the owner demonstrate diligent progress every thirty (30) days in the demolition or repair of the garage or if sufficient progress is not made the Borough would demolition the garage.

**WHEREAS,** testimony, under oath, was taken from Kevin Smith the Borough's Engineer who testified to the following facts:

- 1. Mr. Smith testified that he is a New Jersey Licensed Professional Engineer in good standing with municipal, land development and structural engineering experience;
- 2. Mr. Smith testified that he inspected the garage on or about February 16, 2023, and took a photo of the garage. He testified that the photo shows exposed rafters, no roofing and bowing out on the second-floor siding. Mr. Smith explained the bowing out of the siding was due to the rafters and ceiling joists becoming disconnected.
- 3. On August 28, 2023, Mr. Smith inspected the garage and took photos. Mr. Smith testified that the photos depicted that the second-floor walls had fallen off and rafters missing, the bowing out of the first floor walls resulting in the floor joist to lose support and partial failure of the floor of the second floor.
- 4. Mr. Smith testified, that due to the balloon framing of the garage, if nothing is done, the other three walls will fail and collapse outward into the alley and into the adjoining neighbor's garage.
- 5. Mr. Smith testified that during his August 28, 2023 inspection, he looked into the window and observed the interior framing of the garage and that the interior framing was weathered and rotted due to a lack of a roof to protect the framing from the weather.
- 6. Mr. Smith testified that in his opinion, it would be unlikely that a structural engineer would, due to the instability of the garage, enter the garage to perform an inspection necessary to determine if the garage was salvageable.
- 7. Mr. Smith opined that due to the extent of deterioration of the garage, the only way to restore it would be to demolition the garage and rebuild on the foundation.
- 8. Mr. Smith stated that the garage was within a foot or so of the alley and that anyone near the garage when it collapses would be injured.
- 9. Mr. Smith further testified that the collapse of the garage would, due to the garage's proximity to the adjoining property owner's garage, cause property damage to the adjoining neighbor's garage.
- 10. Mr. Smith testified that he concurred with Mr. Rossi that ninety (90) days to demolition the garage was reasonable so long as the owner showed progress in permitting, contracting a contractor and removal of the garage.

**WHEREAS,** at the hearing, the owner of the garage was represented by her daughter Niddia Copasso and the owner's son Ceasar Malaret. Both Ms. Copasso and Mr. Malaret stated they have power of attorney for the owner.

**WHEREAS**, Both Ms. Copasso and Mr. Malaret were given an opportunity to cross examine the Borough's witnesses, present their own witnesses and to make a statement to the Council;

**WHEREAS,** Niddia Copasso only wanted to make a statement. She stated that she wanted to have the garage demolished and had contacted Mr. Rossi to obtain information and was contacting contractors to perform the demolition.

WHEREAS, Ceasar Malaret only wanted to make a statement to the council. He stated that while he would like to save the garage, he understood that it needs to be taken down. Mr. Malaret requested that there be flexibility in the ninety (90) day period.

**NOW THEREFORE, BE IT RESOLVED**, the Borough Council having heard the testimony of Joseph Rossi and Kevin Smith and the statements on behalf of the owner of the garage by Nidia Copasso and Ceasar Malaret resolve and ORDER:

- 1. The garage at 181-183 Belvidere Avenue, Borough of Washington, Warren County, New Jersey Tax Block 20.03 Lot 2 is unfit for habitation;
- 2. That the owner has ninety (90) days to demolish the garage and that the demolition will comply with all legal requirements.
- 3. Mr. Rossi shall devise a progress schedule for the ninety (90) day period for the demolition of the garage and provide same to owner;
- 4. If the owner does not meet the progress schedule, Mr. Rossi shall notify the owner that the demolition is not in compliance with the Council's Order and provide a reasonable amount of time, at his discretion, to bring the demolition into compliance.
- 5. In no event shall the owner be permitted any extensions which would cause the total time of the demolition of the garage to take more than one hundred twenty (120) days from the date of this Resolution.
- 6. If the owner fails to bring the demolition into compliance or the demolition is not completed in one hundred twenty (120) days of the date of this Resolution, the Borough shall then take over the demolition of the garage.
- 7. If the Borough takes over the demolition or the owner's demolition causes the Borough to incur any cost or expense, in accordance with Borough Ordinance Chapter 31, the owner shall be liable to the Borough for all costs and expenses incurred by the Borough;
- 8. If after thirty (30) days from the date the Borough serves demand for payment on the owner for the costs and expenses incurred by the Borough for the demolition of the garage, the owner has not reimbursed the Borough for the Borough's costs and expenses, the Borough shall, in accordance with Ordinance Chapter 31, file a lien against the owner's property and commence foreclosure to collect all amounts legally due and owing the Borough.

- Mayor Conry says she wants to see a Veteran get this house if it can happen to get it fixed up for a veteran here in borough.
- France mentioned stigma free environment -a week ago a couple of young teenagers
  picking on some people in community-did it one day and another-he told them to chill
  out-they were getting mustered in which he called the police and added that they were
  very obnoxious.

- Thanked everyone for coming out and thanked everyone for a productive meeting.
- Reiterate our children are our future we must focus attention on the children.
- Safety is most important thing too.
- Thanked Josephine for coming out to give us the information.
