Sidewalk Ordinance Discussions

Attorney Peterson started discussions with a history of the ordinances and stated he made some changes. Purpose of the workshop is to talk and work through so everyone is on same page to decide on how to go.

Issues that were discussed were how far back from store front and if length of facade would be the permitted area. Keeping the downtown clean and clutter free.

Discussions ensued regarding sidewalks and what should be in place and limiting to what is placed on the sidewalks and what regulations should be implemented.

Mel Thiel, BID Executive Director

Thanked everyone involved and everyone that came out for the Festival in the Borough-it was the biggest in the 19 years. No issues. There was also two grand openings on Saturday as well.

Thanked DPW for all the help in the planning process as well as the Fire Company and Police Department.

Next event is Day of the Dead on Thursday October 26th.

Hometown Halloween is on October 31st.

Mrs. Thiel gave some input regarding the sidewalk ordinances. Spoke with businesses all want to remain anonymous in which Mrs. Thiel stated she will respect that. Few businesses would like to see more restrictions on what is out. Brings attention to downtown whatever is outside.

Feels the whole length of facade should be acceptable and 6 feet out as along as ADA compliant. Discussed issues with code enforcement.

Mrs. Thiel voice her objection to a separate license and explained that all businesses already have a business license as it is.

Discussed issues with the abandoned buildings that still have their signs on the buildings.

<u>Debra Schlief (sp) 189 W Washington Avenue</u>- spoke highly of Get-A-Grip store in downtown citing its uniqueness and beauty specially during holidays. Asked why borough would fight something like that-makes town warm and friendly.

<u>Marco Matteo-7 Railroad Avenue</u>-spoke about the recent court case involving the theatre management and code violations. Demanded council to take some sort of immediate action of the condition of the building.

ORDINANCE 2023-18

Ordinance Amending Chapter 85 of the Code of the Borough of Washington, entitled "Municipal Parking Lots"

WHEREAS, the Borough of Washington Chapter 85 of the Code which provides the regulations governing the use of the municipal parking lots;

WHEREAS, with the increase in the number of electric vehicles the Mayor and Borough Council have determined that having electrical vehicle stations in municipal parking lots will benefit the residents of Washington Borough.

WHEREAS, the Mayor Borough Council desires to amend its ordinances to ensure that those parking stalls in municipal parking lots shall be available to only individuals with electric vehicles.

WHEREAS, the Borough Council desires to further amend its ordinances to provide ticketing and towing for violating the electrical vehicle parking ordinance and;

<u>Section 1.</u> Chapter 85 of the Code of the Borough of Washington, entitled "Municipal Park Lots" shall be amended as follows (deletions noted with strikethrough thus and additions noted in bold italic *thus*):

§85.66

- A. No person shall stop, stand or park any non-electric vehicle in a space designated through signage as an electric vehicle charging station.
- B. No electric vehicle shall park in a space designated, through signage, as an electric vehicle charging station when either (1) the electric vehicle is not electrically charging or (2) is parked in the parking space for more than two (2) hours. For purposes of this subsection, "charging" means an electric vehicle is parked at an electric vehicle charging station and is connected to the charging station equipment.
- C. Vehicles parked in violation of these regulations will be subject to ticketing and/or towing in accordance with §§ **85-63** and **85-64** of the Code of the Borough of Washington.

Section 2. All ordinances or parts of ordinances inconsistent herewith are repealed as to such inconsistencies.

<u>Section 3.</u> If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

Section 4. This Ordinance shall take effect upon final passage and publication according to law.

- Will bring up at next Shade Tree meeting and stated that the Shade tree would like their own page on the new website.
- Mentioned branding and what it means to Washington Borough.

Councilwoman Cox gave the following remarks:

- Festival was very nice.
- Nice to attend the Habitat building with the dance. Hopefully get them in as an act with BID for next year.
- Hope to come to agreement with sidewalk (ordinance) Outburst of some things that happened here have to be addressed, have to have a decorum.
- DPW- they do everything as far as garbage; put cans back etc., the problem is this, me standing in my doorway watching or looking out to see what vehicle is coming to pass, it is only the responsibility of DPW to pick up my trash, leaves, and garbage and to not pay attention to me at my doorway making faces or hand gestures or calling someone else on council a name.

Councilman France gave the following remarks:

- Inquired about sidewalks grant, Manager Bond explained in further detail the aspects of what it covers and it being a federal grant.
- Mentioned Marco and stated that he is a very passionate person about this town hope no one misinterprets his passion. He wants things addressed. Don't judge him harshly he's an asset to town. A \$100 fine is silly for the theatre. They don't take it seriously. The owner of building was promised in past but holding back until that gets done.
