The regular meeting of the Borough Council of Washington, Warren County, New Jersey was held in councils chambers at 7:00 P.M.

Roll Call: Brown, Cox, France, Gorshkov, Infinito, Musick and Conry

Borough Manager, Brian BondAbsent:NoneMayor Conry led everyone in the flag salute.

Mayor Conry read the following statement into record:

The requirements of the Open Public Meetings Law, P.L. 1975, Chapter 231 have been satisfied in that adequate notice of this meeting has been published in the Express-Times (Warren County Edition and Star Ledger) and posted on the Boroughs website stating the time, place and purpose of the meeting as required by law

WORK SHOP 6PM

Sidewalk Ordinance- Discussion continuation-starting with footage. The majority consensus of footage is at four feet.

Months of operation: Attorney Peterson explains the months of operation as discussed at last meeting. Restricting it to certain months was discussed. Discretion of manager based on weather conditions; snow and winter weather were suggested by Attorney Peterson. It was the consensus of the council to allow the discretion of the manager during winter to use his discretion. Clearance of fire hydrants to be cleared was discussed.

Fee Schedule: Manager Bond discussed his recommendations for establishing a fee schedule.

Attorney Peterson will finish amending the draft and move forward for introduction at our next meeting on November 21, 2023.

<u>Motion</u>

A motion to open meeting up to public comment, made by Infinito, seconded by Brown.

Roll call: Brown, Cox, France, Gorshkov, Infinito, Musick and Conry. Ayes: 2 Nays: 5 Motion fails.

Attorney suggested a sidewalk signage workshop at the next meeting at the same time at 6PM at the November 21st meeting.

Motion to adjourn workshop made by Cox and seconded by Musick all in favor with the exception of Brown and Infinito voting no.

7:00 PM -Regular Meeting

PUBLIC COMMENT

Motion made by Cox and seconded by Gorshkov to open the public portion of the meeting, all were in favor.

<u>Rubin Moreno</u>, non-resident, is proposing an idea and stated he is here tonight to see if he should pursue it or move on. Looking to purchase property for a non-retail cannabis operation being a cannabis logistics center for various companies.

<u>Michele Stemkowksi (sp</u>), non-resident stated she has been doing the flowers for Get a Grip for past four years. An issue last week with the motor vehicle on sidewalk. Pointing out Ordinance 75-7. Asked if council is picking and choosing.

<u>Joe Skalaru (sp)</u>, non-resident, here on behalf of Dan Rossi, discussed alleged vehicle on sidewalk in front of Get a Grip. Addressed with concerns of application of a broad cutting statute that was discussed here with regards of the footage between four and six feet. Give impression of passersby to give people impression of this town being very alive.

<u>Diane Malenga</u>, non-resident, stated that after hearing awful disparaging comments coming from council members, they need to apologize. Discussion of the cost of rents downtown and fees associated with proposed ordinance.

<u>Nancy Redish</u>, non-resident, addressed council on issue of proposed ordinance. Expressed support for Get A Grip and businesses of the downtown.

<u>Rachel Collier</u>, business owner, non- resident, inquired about cement barriers that have been sitting and not removed. Addressed Councilwoman Gorshkov regarding an apology to business owners. Inquiring about trimming the tree in front of the speed limit sign.

<u>Deanne Woodruff</u>, borough resident, stated it is hard to own a business. If the borough needs to cover the cost of whatever needs to be covered, suggested to charge them (businesses) ten dollars instead of \$75.00 dollars. Using the sidewalk to display things should be able to use them. Stated that council should try and support the business and anyone else who wants to open up a shop.

<u>Nicole Kries</u>, borough resident and business owner, came to this town, and has a second store. Came into town expected support, which she received but found out about fees and rules, it is extremely hard to run a business. Stated that she would love to have council patronize their stores.

<u>Scott Cassles</u>, non-resident, owns Scotty's, stated that the town needs a pickup needs a draw needs something for someone to stop. Cars fly by, borough needs something. Stated that this is his first council meeting ever.

<u>Chris Bauknight</u>, borough_resident, stated that it is nice to see a lot of people out tonight. Stated that this topic (sidewalk ordinance) has been arguing about this awhile. Theres needs to be a solution. Stated that we can't compare cities., we are Washington, we have an identity of our own , support each other.

<u>Cathy Laporte, non-resident</u>, businesses in borough, pointed out her viewpoints to the car at Get A Grip, citing that it brought people here and people taking pictures in front of the car. Expressed the mounting fees and expenses businesses have to pay. Stated that she has never been able to make a living here. Puts heart into her business and her fair-trade business. Thanked the council members who have stopped in once in a while. Suggested to form a separate committee with council and the BID members and working out something that will work for everyone.

<u>Andre Walters</u>, non-resident, works at local business and noticed the vehicle at Get A Grip, inquired about the issue of the vehicle. Stated it is a very unique display.

<u>John Thompson</u>, non-resident, stated he patronizes this town as much as he can. Voiced his support for Get A Grip. Pointed out other areas of borough that are in worse shape. The vehicle is a great display which this town needs.

<u>Tom (last name inaudible)</u>, borough resident, stated his wife owns store in borough, discussed the four feet disagreement and the charge for it. Stated he owns the property. Needs to be room for discretion. Pleaded to Council to tread carefully.

<u>Jessica Sputnak (sp</u>) borough resident voiced her support for Dan Rossi his passion for this town and thanked Mel (BID Executive Director). Shameful of bickering between members. Interested in helping anyway she can.

<u>Dan Rossi</u>, borough <u>r</u>esident and business owner, hired a business consultant and did a business survey which was handed out to council. Referred to his report in relation to his business Get A Grip and showed a display in regards to his report.

<u>Joe Kappa(sp)</u> non-resident_stated that this town needs all these little businesses, or this will be a ghost town. Asked for everyone to work together and help these businesses and not hurt them with these fees.

<u>Denise Coleman</u>, non-resident, stated if you're having issues with the businesses downtown, she recommended consulting with the BID and businesses.

<u>Lisa Tolfinger (sp)</u>, non- resident, discussed the little fees that are ruining towns. Stated she does historical reenacting, whenever she's in town she takes a picture of Mr. Rossi's store and posts it on social media. Council should be representative of the businesses for the good of the businesses.

Ken (no last name given), borough resident, stated he learned a lot tonight and still has a lot to learn. Stated he believes a community should stick together. Does believe a mistake was made to not have this side speak during the workshop. Asked why they weren't able to speak during the workshop.

Hearing no further public comment, motion made by Cox and seconded by Gorshkov to close the public portion all were in favor.

REPORTS

Committee Reports:

<u>Recreation</u>-France stated he is working with manager with the gentleman who heads up the 501c and a meeting will be sometime this week.

Land Use Board-Mayor Conry stated that the meeting was canceled last night, applicant was not prepared.

<u>Streets</u>-Brown reported that striping is being measured for a couple of roads in question, he is working with manager in getting costs.

<u>Ordinance</u>-Gorshkov reported that she was looking into fees that are on the books from the 70's and 80's in which the manager is also working on these.

<u>Managers' Report-</u> Manager Bond reported that the QPA Rose Witt has retired and there is a resolution to appoint Hector Herrera, a qualified QPA. Manager Bond stated a request to use borough council chambers on an evening where no one normally works was made. This would involve having to call an employee to come in and pay them overtime to open the doors, Washington Community Garden wants to use council chambers for three Wednesday nights. Since bringing someone to come open doors,

suggested to pass a motion for that fee to be passed along to them instead of having taxpayers take up the cost.

Attorney Peterson, gave the following updates:

181-183 Belvidere Avenue- the son did acquire the permits. First floor still up. Need to see if he is going to finish taking down rest of building. Will follow up to make sure its taken down to concrete pad.

Washington Station Ventures-received a phone call and email from Washington Station Ventures, this is the thirty-five acres, near cemetery. They want to know if we have a consensus, they will sell ten acres of cemetery which is part of an agreement and pay the affordable housing fee and then deed the rest to the town the remaining portion to borough (25 acres). Consensus of council agreed. Will need to change settlement agreement. Peterson explaining builders remedy with regards to COAH.

Attorney Peterson reported that he met with the Planner and had conference call with Attorney that represents the soon to be applicant for old gas station on corner of 57 and 31 about the design. There will need to be a process to amend a redevelopment plan to allow a gas station and make sure it makes sense to the whole plan. Make it enticing for people to invest and part of that is the design. Some issues to work out and tie it in with the project.

ORDINANCE 2023-18 Ordinance Amending Chapter 85 of the Code of the Borough of Washington, entitled "Municipal Parking Lots"

WHEREAS, the Borough of Washington Chapter 85 of the Code which provides the regulations governing the use of the municipal parking lots;

WHEREAS, with the increase in the number of electric vehicles the Mayor and Borough Council have determined that having electrical vehicle stations in municipal parking lots will benefit the residents of Washington Borough.

WHEREAS, the Mayor Borough Council desires to amend its ordinances to ensure that those parking stalls in municipal parking lots shall be available to only individuals with electric vehicles.

WHEREAS, the Borough Council desires to further amend its ordinances to provide ticketing and towing for violating the electrical vehicle parking ordinance and;

Section 1. Chapter 85 of the Code of the Borough of Washington, entitled "Municipal Park Lots" shall be amended as follows (deletions noted with strikethrough thus and additions noted in bold italic *thus*):

§85.66

- A. No person shall stop, stand or park any non-electric vehicle in a space designated through signage as an electric vehicle charging station.
- B. No electric vehicle shall park in a space designated, through signage, as an electric vehicle charging station when either (1) the electric vehicle is not electrically charging or (2) is parked in the parking space for more than two (2) hours. For purposes of this subsection, "charging" means an electric vehicle is parked at an electric vehicle charging station and is connected to the charging station equipment.
- C. Vehicles parked in violation of these regulations will be subject to ticketing and/or towing in accordance with §§ **85-63** and **85-64** of the Code of the Borough of Washington.

Section 2. All ordinances or parts of ordinances inconsistent herewith are repealed as to such inconsistencies.

Section 3. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

Section 4. This Ordinance shall take effect upon final passage and publication according to law.

- The method of having these workshops is very good and informative to him and the public.
- Public mentioned about people can leave stuff and it doesn't get stolen. Credit the police department. Appreciate everyone working together . Town is improving and optimistic about town.

Councilman Infinito gave the following remarks:
