Mayor Conry led everyone in the flag salute.

Mayor Conry read the following statement into record:

Commissioner Kern administered the oath of office to Infinito.

### **PUBLIC COMMENT**

Motion to open public comment made by Cox seconded Gorshkov, all were in favor.

<u>Mark Van Deursen, Chief of Washing Emergency Squad</u>-recapped the year and what they are expecting for next year:

Year to date over 1500 responses and on pace to go to 1700, which is down five percent from last year. They continue to see a decrease related to traffic accidents, a lot of the tech is from cars stopping themselves. Seeing decrease of overdose emergencies, public access to medications is a big contributing factor. They are continuing to strengthen mutual agreements with other agencies. They welcomed five new career employees this year. They are working with ER nurses to bring them out into the field. Continuing to see a shift in distribution of career to volunteers. Less volunteering but more going the career path. Response policies was discussed. They purchased an automated chest device that does automated chest compressions. They are currently working on the toy drive which is specific to local residents who apply. Discussed new billing practices to maintain federal compliance. Introduced John Mitchel who will take over as Chief January 1<sup>st</sup>.

#### Mel Thiel, Executive Director of the BID

Ms. Thiel gave the following report:

- Recapped recent events, Hometown Holiday and Small Business Saturday was this past Saturday; 127 shopping passes were purchased.
- A survey was done to all of the businesses, which results showed it was the best small business Saturday.
- Thanked Washington Fire Department and DPW for all their assistance with the Christmas tree.
- A special thank you to Chris Infinito with the idea of a Community Christmas ornament to be hung on the tree.
- Operation Toy Train was on Sat Dec 2<sup>nd</sup>. Had over 2600 toys donated.
- Two grand openings this past Sunday. Thalia Bakery and Sports Academy and added that a few more new businesses will be opening shortly.

<u>Candy DePhillips, Broad Street</u>-asked if there has been any decision on Broad Street and what will happen with all these accidents. Mirrors have been knocked off on cars. Stated that her car received over \$17,000 damage to her car.
