## **OLD BUSINESS:**

Public Hearing: Redevelopment Plan:

The plan was presented to Council at their last meeting and sent to Planning Board for comments and recommendations. Chuck Latini stated that the plan is 99.9% complete. He received comments from Councilman Cioni that need to be added. Mr. Latini reviewed the outline, plan area, visions, goals and the individual sub areas as noted in the plan. Six sub areas identified. Area 1 proposes realigning Star Plaza along Church Street so parking can be located behind building. Area 2 is the new Borough lot with possibility of obtaining other lots for more parking. Area 3 proposes a boulevard effect on Rt. 31 to slow down of traffic. Area 4 & 5 proposes more parking and passive open space. Discussion on ingress/egress on Vanatta. Area 6 proposes consolidation of existing parking and a building on So. Lincoln.

Three zoning districts proposed:

- 1. public park (Alleger)
- 2. gateway (Rt. 31)
- 3. Core (Washington Ave.)

Each district has allowable uses, design standards, prohibited uses, lot requirements, building requirements, signage standards, lighting standards, parking standards, streetscape standards. Grants to be discussed at upcoming meeting on 2/13/09 at the Borough. Implementation plan as four priorities: Priority 1 includes areas 2 & 3; priority 2 includes area 6; priority 3 includes areas 4 & 5 and priority 4 includes area 1.

Chair VanDeursen reviewed the purpose of the plan to new Board members. Mayor McDonald stated that the Governing Body made some critiques but liked the plan overall. No additional comments from professionals or Board members.

Public comments (2 members of the public in audience):

Lauren Forest of Hackettstown came forward. She stated that she will be moving to the Borough in two weeks and asked about flooding with more proposed parking. Chuck reviewed each area and runoff plans for each.

Marco Mateo, Washington Theatre, came forward. Concerns about parking for the theater. Chuck stated that they are looking into the possibility of connecting the Rossi lot to the theater/diner lot.

Public hearing closed.

Adam Fitting stated that it is important to put more emphasis on sustainable design practices. He also stated that he would like to see tattoo parlors removed from being prohibited in sub area 1.

Therefore it was moved by Truman, seconded by Aron to recommend to Council to adopt ordinance and is consistent with the Borough's Master Plan.
