- Rob Bunting - 2 nights per week (men's softball) - need to confirm days of play by March 20th for softball, baseball (youth)
- Beth will mail the fee schedule - 81 Yeomans Ave. ACTION -daily fee $\$ 225 /$ season/ Lights - $\$ 55$ out of borough and days of play to Rob.
- Resident Jeanine Gleba proposed the idea of Recreation running a sport summer camp at the Borough facilities for a user fee (camp plus pool access included). The ideas included running basketball or other sport camps, field trips, possibly sponsored by the Nets or baseball, sponsored by Patriots. Jeanine offered to help with the effort.
- The Committee thanked Jeanine for her volunteerism in support of the Recreation Department. Beth Uporsky noted that softball signups and referee voucher management have gone very smoothly, thanks to Jeanine.
- Dave Hackney - Washington Borough Little League(WBLL), which consists $100 \%$ residents, will change up Memorial field to accommodate softball rec. Little League maintains the field, including fixing backstop. They will also line three fields on Vara for use by softball. The Little League would like Boro park field for 4 to 5 games (Saturday night games). If WBLL shows receipts for costs incurred to maintain Vara, maintain Steinhart and to modify Memorial School field for softball, will Rich consider buying the youth baseball mound* - approx cost $\$ 1200$ ) and waive fees for Steinhart? First step: meet with Rich to discuss WBLL's potential costs:
o Estimated costs of improvements and maintenance $\$ 3200$ materials (not including professional labor donated and improvements to the batting cage)
- Also use the field for April 16 - June 17. Friday night clinic run by Warren Hills LL 6 - 8:30. Warren Hills Little League (separate from WBLL) will incur a fee for usage, including as needed (early in the season.) Season Fee $\$ 225$ - lights to be determined by conversation with Rich.
- All Stars (Warren Hills) will pay $\$ 225$ to have carte blanche use of field from June 15 - Aug 10.
*Mound must be LL approved, tournament approved. Dave Hackney has details and price ranges.
ACTION - Beth will contact Dave to meet with Rich.
