Statement of Adequate Notice

Roll Call

• Present: Victor Cioni, Brian Collum, Tom Iadevaia, Heather Jorgensen, Joe Pinto, Adam Robinson (7:36), Adam Zimmer. Also present: Jeff Greene, Ethel Conry and Susan Turner.

Audience Participation

- Vic moved to open the audience participation portion of the meeting. Seconded by Adam Zimmer. Ayes: 6 Nays: 0. Motion carried. Audience participation portion opened.
- Vic moved to close the audience participation portion. Seconded by Adam Z. Ayes: 6 Nays: 0. Motion carried. Audience participation closed.

Minutes of Prior Meetings

• Vic moved to approve the minutes from the 2/11/15 meeting. Seconded by Adam Z. Ayes: 5 Nays: 0 Abstain: 1 Absent: 3. Motion carried. Minutes approved.

New Business:

• Field Usage Agreement – individuals – Jeff spoke with the Borough Manager and the Risk Assessment personnel regarding the \$1,000,000 insurance coverage requirement in the agreement. It was determined this is mandatory, even if it is an individual or small group. Vic will amend the Pavilion rental agreement and the Field Usage agreement to add "hold harmless" phrasing. He will pass it on to Kristine Blanchard and the attorneys for approval.

Old Business:

- Splash Pad Work on the electrical panel start tomorrow and should take a day and a half to complete. Equipment has been delivered to the DPW garage. The new contract has not yet been signed. It has to go to Borough Council first for approval. Jeff told Kristine the work should start April 1 or be delayed until fall. Suburban Engineering has not answered Jeff's emails.
- Baseball netting Jeff stated he feels the cost should be split evenly between Rec and the Borough. The Borough mandated the netting and they cut down all the trees outside the outfield fence. The project has gone out to bid. 5 poles need to be added. We do not have any schematics for the lighting system underground wiring so the lines have to be traced before the poles are added. The netting will remain up all year and will last 10 years. Commissioners were concerned with the cost versus the safety/liability issue. If the netting is not done there won't be a Men's Softball season. There have been additional

teams who expressed interest in playing at the Borough Park if the netting were in place. Jeff pointed out that the Rec Trust fund is there to improve the Recreation Department. Vic moved that Recreation agree to pay half the cost of the new netting and poles at the Borough Park, not to exceed \$20,000. Seconded by Brian Collum. Ayes: 6 Nays: 0, Abstain: 1, Absent: 2. Motion passed.

- Ordinance dogs on the fields People are letting their dogs run on the fields and are not cleaning up after them. The memo will be updated to include the name, lot and block numbers for Steinhardt and Vara fields. It will have to go before council to be approved as an ordinance which will give us more power to enforce the existing regulations. The lock code will be given to coaches and changed seasonally.
- Security cameras Vic met with the Rotary Club last month with Detective Pantuso to describe the security camera system and ask if they will donate all or some of the \$3400. They will give Vic an answer soon. Jeff noted he has seen a strong police presence at the park lately.

Recreation Director's Report

• Brian asked about the weather's effect on the splash pad plans. Jeff said the installation needs to start by April 1. The project will take 6 weeks but then there will be clean up and grass seed and fencing to see to. Vic said he will email Andrew Holt at Suburban Engineering and Kristine that if the contract is not done by April 1 the project will be put off until the fall and he will make sure everyone knows it is Suburban's fault.

Council Liaison's Report

• Ethel thanked everyone involved in the Basketball program, especially James Sawyer and Coach Nalepa, who coached her grandson.

- Easter Egg Hunt (Heather Jorgensen) –Heather has visited 20 local businesses to solicit donations. The PTO, ShopRite, QuikCheck, A&P, Fliegauf's and the Sharks swim team will all donate. A second set of flyers will go out Thursday, April 2.
