#### New Business:

- Field Usage / Maintenance Fees Corey wanted to clarify what fee would be charged if the Redskins football squad used the Boro Park field for practice; just the daily usage fee or the maintenance fee. After discussion it was determined that they would not incur any additional maintenance requirements and would be charged the daily usage fee.
- Morris County Co-op Softball uniforms The League liaison, Beth Uporsky, recommended we order long pants and Joe Pinto said we were the only team wearing shorts last year. The Morris County Co-op does not have pricing for pants in black or blue. Corey will look into pricing from other providers. Basketball Uniforms Corey reviewed the cost differences of jerseys between the two local suppliers AllSports (who has provided them for the last few years) and Abilities (who has been used primarily for printed tshirts). While the costs were similar a majority of the commissioners agreed that he should use Abilities due to delays experienced several times with AllSports. Rick moved to order the basketball uniforms from Abilities. Seconded by James Sawyer. Ayes: 4 Nays: 0. Motion passed.

• Budget Review – Susan explained the basics for reviewing the reports Adam received from Natasha. Joe asked about the Swim Team Coaches' salary and the amount was shown on the expenditures vs appropriations report. Joe said the Sharks have paid part of the salary in the past as per their contract with the Borough. They have not paid anything this year and Joe does not think they should pay anything this year. Rick had questions regarding the basketball revenue and expenditures. Susan explained that the revenue is received in the fall but most of the expenditures occur in January and
